

Road and the north-eastern side of Turoa Road to a point on the northern boundary of Lot 1 on plan 5177 deposited as aforesaid; thence westerly along that boundary to the north-eastern side of Turoa Road; thence south-easterly along that side to the northern boundary of Lot 12A on plan 1872, deposited as aforesaid; thence along the western and southern boundaries generally of the said Lot 12A, to the western boundary-line of Lot 1 on plan 1954 deposited as aforesaid; thence southerly along the western boundary-line of the said Lot 1 to its intersection with a line parallel to No. 2 Line of Road and 749-2 links distant therefrom; thence by that line to the south-eastern boundary-line of Section 44, left bank Wanganui River, Block V, Ikitara Survey District; thence south-westerly along the south-eastern boundary of the last-named section to No. 2 Line of Road, and by a right line across that road to and along the western side of a road opposite the south-eastern corner of aforesaid Section 44; thence westerly along the northern side of that road to the eastern boundary of Te Iwi Roa Block; thence northerly along the eastern side of that block to Section 29, Block V aforesaid; thence westerly generally along the southern boundaries of said Section 29, Manawakawara No. 3, and Kaiate No. 2 Blocks, and the production of the southern boundary of the last-mentioned block to the Wanganui River; thence northerly generally along the left bank of the Wanganui River to the place of commencement: including the wharf and bridge as defined in the Wanganui Bridge and Wharf Act, 1872, and also the bridge as defined in the Wanganui River Bridge No. 2 Act, 1911.

SECOND SCHEDULE.

BOUNDARIES OF COUNTY OF WANGANUI.

ALL that area in the Wellington Land District bounded by a line commencing in the middle of the Wanganui River at a point opposite the north-western boundary of the Ohoutahi Block; thence to and along that boundary and along the north-western boundaries generally of the Otaranoho Block to the north-eastern corner of Section 11, Block XI, Rarete Survey District; thence southerly generally along the eastern boundary of Section 11 aforesaid, the northern and eastern boundary of Section 17, Block XI, aforesaid to the Mathihope Stream; thence up the middle of that stream to its intersection with the south-eastern boundary of Morikau No. 1 Block; thence south-westerly along that boundary to its intersection with the north-western boundary of the Ranana Block; thence along the northern boundaries of the Ranana Block, the northern, eastern, and southern boundaries of the Ngarakauwhakarara Block, to the eastern boundary of Section 1, Block VII, Tauakira Survey District; thence southerly along that boundary to the middle of the Matahiwi Road; thence easterly generally along that road to the north-western corner of Section 4, Block V, Ngamatea Survey District; thence southerly along the western boundaries of Sections 4 and 3, Block V aforesaid, and Section I, Block IX, to the Aratawa Trig. Station; thence along the southern boundary of Section 1 aforesaid, and the northern boundary of Ohotu No. 9 Block to the Mangawhero River; thence up the middle of the Mangawhero River to the middle of the Auraki Stream; thence up the middle of that stream to the south-western boundary of Lot 1 on plan 4978 deposited in the office of the District Land Registrar at Wellington; thence along the south-western and north-western boundaries of the said Lot 1 to Lot 2 of said plan 4978; thence along the north-western and north-eastern boundaries generally of the said Lot 2 to the north-western boundary of Ohotu No. 6B; thence along the north-western boundary of the said Ohotu No. 6B Block to the Karokio Stream; thence along that stream and the northern boundaries generally of the Ohotu 6A No. 1B Block to the Waokaramu Stream; thence down the middle of that stream to the Wangaehu River, and up the middle of that river to the north-western corner of Section 1, Block IV, Ngamatea Survey District; thence easterly along the northern boundaries of Sections 1, 8, 6, and 7, Block IV aforesaid, to the north-eastern corner of the last-mentioned section; thence southerly along the eastern boundary of the said Section 7, the eastern boundaries of Sections 6 and 9, Block VIII, Ngamatea Survey District, and the northern boundary of Pungataua Block and its production to the middle of the Koukoupo Road; thence south-westerly along the middle of the said road to a point in line with the south-western boundary of Section 71, Block XII, Ngamatea Survey District; thence to and along that boundary and the south-western boundary of Section 70, Block IX, Maungakaretu Survey District and its production to the middle of Hales Road; thence south-westerly along that road to a point in line with the north-eastern boundary of Section 77, Block XVI, Ngamatea Survey District; thence to and along the north-eastern boundary of the said Section 77 and the southern boundary of Section 63, Block XIII, Maungakaretu Survey District, to the summit of the eastern watershed

of the Wangaehu River; thence by lines from hill to hill along the summit of the eastern watershed aforesaid to a right line passing through the Okaipepe Trig. Station to a point in the middle of the Wangaehu River; distant about 18 chains due west of the western boundary of Block XIV, Mangawhero Survey District; thence down the middle of the said river to the sea-coast; thence north-westerly along the sea-coast to the middle of the Wanganui River, and up the middle of that river to the point of commencement: excluding that part of the City of Wanganui, hereinbefore described, lying within the area specified herein.

BOUNDARIES OF COUNTY OF WAITOTARA.

All that area in the Taranaki and Wellington Land Districts bounded by a line along the middle of the Wanganui River from its intersection by a right line running from Mount Humphries to the confluence of that river with the Tangarakau River to the sea, along the seashore to the mouth of the Waitotara River, and along the middle of that river to a point opposite the mouth of the Mangaone Stream, to and along that stream and along the southern boundary of Section 16, Block V, Nukumaru Survey District, to Wharekarangi Trig. Station; thence along the eastern boundary of Section 16 aforesaid to and along the Mangaone Stream to the south-eastern corner of Lot 4 on plan No. 659, deposited in the office of the District Land Registrar at Wellington; thence along the south-eastern boundary of that lot to and across the Waitotara Road and along the western boundaries of Lots 14 and 17 on plan No. 918 deposited as aforesaid, to Orangihoangi Trig. Station, and along the south-eastern and north-eastern boundaries of Section 11, Block XIV, Momahaki Survey District, and the Mangamingi Stream, to and along the Te Korokio Stream, and along the western and northern boundaries of the Manganui-o-Tahu Block to the western boundary of Lot 3 of Mangapapa No. 1B Block; thence along that boundary and the western and northern boundaries of Lot 1, Mangapapa 1B Block, to Watershed Road, and along the middle of that road and the summit of the range over Maungarau Trig. Station to Mount Humphries; and thence along a right line running in the direction of the confluence of the Tangarakau River with the Wanganui River to the middle of the latter river the place of commencement, and excluding that part of the City of Wanganui hereinbefore described, within the area herein specified.

THIRD SCHEDULE.

BOUNDARIES OF MANGAWHERO RIDING, COUNTY OF WANGANUI.

ALL that area in the County of Wanganui bounded on the north by the county boundary hereinbefore described from the Aratawa Trig. Station to the intersection of Field's Track by the Waokaramu Stream; thence westerly and southerly along the middle of Field's Track to its junction with the stock road intersecting Parapara 2B 1 Block and forming the western boundary of Parapara 2B Block and Sections 12 and 13 (Taonui Block), Block XV, Ngamatea Survey District, Sections 2 and 3 (Taonui Block), Block III, Mangawhero Survey District, Sections 1, 2, 3, and 4 (Heao Block), Block VII, Mangawhero Survey District, Sections 5, 6, and 7 (Heao Block), Block X, Mangawhero Survey District; thence along the north-western boundary of Section 8 (Heao Block), Block X aforesaid, the south-western boundaries of Sections 18, Block X, and 19 and 20, Block IX, Mangawhero Survey District, to the stream forming the northern and eastern boundaries of the Pohuehue Block and part of the eastern boundary of the Pikopiko No. 3 Block; thence along that stream to the northern boundary of the Te Maire Block; thence along the northern and western boundaries of the Te Maire Block and the eastern boundary of Block XVI, Waipakura Survey District; thence along the eastern boundary of Section 305, Block I, Wangaehu Survey District, to the south-eastern corner of the said Section 305; thence north-westerly along the northern boundaries of Sections 304, Block I, Wangaehu Survey District, Sections 329, 331, 332, 333, 334, 335, and 336, Block IV, Ikitara Survey District; thence along the northern and western boundaries of Sections 339, 340, 341, 351, and 352, Block III, Ikitara Survey District; thence along the northern boundaries of Section 361, the northern and western boundaries of Section 360, the western boundary of Section 295, and the northern boundary of Section 293, Block III, Ikitara Survey District; thence along the northern and western boundaries of Section 292, Block II, Ikitara Survey District, to the stream intersecting Sections 120, 119, 118, and 117; thence along that stream to the road angle in the last-mentioned section, across that road, and along the southern boundary of Section 109, Block II aforesaid, and the western boundary of Section 81, Block II aforesaid, to the north-eastern corner of Lot 9 on plan 902 deposited in the office of the District Land Registrar at
