Proclaiming Native Land to have become Crown Land.

[L.S.] CHARLES FERGUSSON, Governor-General. A PROCLAMATION.

WHEREAS by section fourteen of the Native Land Amendment Act, 1914, it is provided, inter alia, that on being satisfied that the purchase of any Native land has been duly completed by or on behalf of the Crown under the authority of the Native Land Act, 1909, the Governor-General may issue a Proclamation that such land has become Crown land:

And whereas the purchase of the Native land set out in the Schedule hereto has been duly completed by or on behalf of the Crown under the authority of the Native Land Act, 1909, and its amendments:

Now, therefore, in pursuance and exercise of the power and authority so conferred upon me by section fourteen of the Native Land Amendment Act, 1914, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim that the Native land set out in the Schedule hereto has become Crown land.

## SCHEDULE.

TANGATAPU 1a Block, Omapere Survey District: Approximate area, 40 acres.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand, and issued under the Seal of that Dominion, this 29th day of August, 1927.

WHEREAS by section forty-seven of the Land for Settlements Act, 1925, it is, amongst other things, enacted that in no case shall any money be expended under the provisions of the said section forty-seven in connection with any block of land, unless that block is set apart for selection subject to the special provisions of that section: Now, therefore, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, in pursuance and exercise of every power and authority enabling me in this behalf and for the purposes of the aforesaid section forty-seven, do hereby proclaim the land described in the
