

Electrical Wiremen's Registration Act, 1925.

RESULTS OF EXAMINATION, OCTOBER, 1926.

PURSUANT to Regulation 4K of the Electrical Wiremen's Registration Regulations, 1926, notice is hereby given of the results of the examination held in October, 1926.

The Electrical Wiremen's Registration Board of New Zealand held its first examination for electrical wiremen under the Act passed in 1925 on the 29th and 30th October, 1926. Of the 179 candidates who presented themselves for examination, 171 sat for the practical part and 167 for the written part. In the practical part 133 candidates passed, and 110 in the written part.

Examinations were held in the following centres, and the number of candidates and also those who passed is included.
