Now, therefore, in pursuance and exercise of the powers and authorities so conferred upon me by the aforesaid section, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby proclaim and declare that from and after the seventh day of September, one thousand nine hundred and twenty-seven, the land described in the Schedule hereto, which was set apart as national-endowment land under the provisions of section two hundred and fifty-eight of the Land Act, 1908, shall cease to be national-endowment land.
