Additional Land at Puhinui taken for the Purposes of the Kaipara - Waikato Railway, and for Street - diversion in connection therewith.

W HEREAS it has been found desirable for the use, Convenience, and enjoyment of the Kaipara-Waikato Railway to take further land at Puhinui, in addition to land previously acquired for the purposes of the said railway, and to take land for street-diversion in connection therewith.
