HIGHWAY DISTRICT No. 12.

Westport-Greymouth (Coast Road).

All that road or portion of road in the Buller County, commencing at its junction with the Westport-Nelson Main Highway at a point opposite the eastern boundary of Section 27, Block VII, Steeples Survey District, and proceeding generally in a south-westerly direction via Greymouth-Westport Road, Charleston, and Brighton, and terminating at the right bank of Fox's River, being a distance of 25 miles, more or less. Shown on plan P.W.D. 71520, and thereon coloured black.

Also all that road or portion of road in the Grey County, commencing at the left bank of the Punakaiki River, and proceeding generally in a southerly direction via Main North Road, Barrytown, Twelve Mile, Seven Mile, and Runanga, and terminating at the northern boundary of the Borough of Greymouth (Cobden Bridge), being a distance of 26 miles 20 chains, more or less. Shown on plan P.W.D. 71521, and thereon coloured black.

Also all that street or portion of street in the Borough of Runanga commencing at the northern boundary of the Borough of Runanga, and proceeding generally in a southerly direction via Seven-mile Road, and terminating at the southern boundary of the Borough of Runanga, being a distance of 1 mile 53 chains, more or less. Shown on plan P.W.D. 71521, and thereon coloured black.

Also all that street or portion of street in the Greymouth Borough, commencing at the northern boundary of the Borough of Greymouth (Cobden Bridge), and proceeding generally in a southerly direction, and terminating at its junction with Mawhera Quay, being a distance of 2 chains, more or less. Shown on plan P.W.D. 71250, and thereon coloured blue.

Ahaura-Haupiri.

All that road or portion of road in the Grey County, commencing at its junction with the Inangahua Junction - Waiho Main Highway in the Ahaura Township, and proceeding generally in a south-easterly direction via Ahaura-Amuri Road, and terminating at the right bank of the Ahaura River at the Haupiri Settlement, being a distance of 23 miles 38 chains, more or less. Shown on plan P.W.D. 71521, and thereon coloured black.

Kokatahi-Koiterangi.

All that road or portion of road in the Westland County, commencing at its junction with the Lake Kanieri Road opposite the north-eastern corner of Section 628, Block V, Mahinapua Survey District, and proceeding generally in a southerly direction via Kokotahi Road, Koiterangi Main Road, Cropp Road, and Hokitika Flat Road, and terminating at its junction with McArthur Road at a point opposite the southern corner of Section 211, Block 13, Mahinapua Survey District, being a distance of 12 miles, more or less. Shown on plan P.W.D. 71522, and thereon coloured black.

Upper Kokatahi.

All that road or portion of road in the Westland County, commencing at its junction with the Kokatahi Road at the southern corner of Section 1225, Block IX, Mahinapua Survey District, and proceeding generally in a south-easterly direction, and terminating at its junction with Doughboy Road, being a distance of 4 miles, more or less. Shown on plan P.W.D. 71522, and thereon coloured black.

Lake Kanieri Road.

All that road or portion of road in the Westland County, commencing at its junction with the Inangahua Junction-Waiho Main Highway at Kanieri, and proceeding generally in an easterly direction, and terminating at its junction with Sunny Bright Road on the northern shore of Lake Kanieri, and being a distance of 8 miles 55 chains, more or less. Shown on plan P.W.D. 71522, and thereon coloured black.

Reefton-Maruia.

All that road or portion of road in the Inangahua County, commencing at its junction with the Inangahua Junction-Waiho Main Highway, in the Reefton Township, and proceeding generally in a south-easterly direction, and terminating at Springs Junction, being a distance of 28 miles, more or less. Shown on plan P.W.D. 71523, and thereon coloured black.

HIGHWAY DISTRICT No. 13.

Dashwood-Upcot.

All that road or portion of road in the Awatere County, commencing at its junction with the Christchurch-Blenheim, via Parnassus, Main Highway at Dashwood, and proceeding generally in a south-westerly direction along the banks of the Awatere River, and terminating near Upcot, opposite the northern corner of Section 7, Block 22, Hodder Survey District, being a distance of 40 miles, more or less. Shown on plan P.W.D. 71524, and thereon coloured red.

Waiau-Lyndon.

All that road or portion of road in the Amuri County, commencing at its junction with the Waipara-Kaikoura, via Culverden, Main Highway near Waiau, and proceeding generally in a westerly direction, and terminating at a point opposite the eastern boundary of Section Part 168, Block XV, Lyndon Survey District, being a distance of 9 miles 20 chains, more or less. Shown on plan P.W.D. 71525, and thereon coloured red.

Flinthoff - Mouse Point.

All that road or portion of road in the Amuri County, commencing at its junction with the Waipara-Kaikoura, via Culverden, Main Highway at Flinthoff, and proceeding generally in a westerly direction, and terminating at its junction with the Culverden-Hammer Main Highway opposite the eastern boundary of Section 26, Block II, Culverden Survey District, being a distance of 2 miles 40 chains, more or less. Shown on plan P.W.D. 71525, and thereon coloured red.

Waiau Road.

All that road or portion of road in the Kaikoura County, commencing at its junction with the Christchurch-Blenheim, via Parnassus, Main Highway at the Kowai River, and proceeding generally in a north-westerly direction, and terminating at its junction with the Waipara-Kaikoura, via Culverden, Main Highway at school corner opposite the northern corner of Section 231, Block IX, Mount Fyffe Survey District, being a distance of 2 miles, more or less. Shown on plan P.W.D. 71526, and thereon coloured red.

Beach Road.

All that road or portion of road in the Kaikoura County, commencing at its junction with the Christchurch-Blenheim, via Parnassus, Main Highway, and proceeding generally in a south-easterly direction, and terminating at the entrance to the Kaikoura Wharf, being a distance of 1 mile, more or less. Shown on plan P.W.D. 71526, and thereon coloured red.

Puhipuhi Road.

All that road or portion of road in the Kaikoura County, commencing at its junction with the Christchurch-Blenheim, via Parnassus, Main Highway at the Hapuka River, and proceeding generally in a north-easterly direction via the left bank of the Puhipuhi River, and terminating opposite the junction of the Clinton Stream with the Puhipuhi River, being a distance of 3 miles 60 chains, more or less. Shown on plan P.W.D. 71526, and thereon coloured red.

Motunau - Motunau Beach.

All that road or portion of road in the Waipara County, commencing at its junction with the Christchurch-Blenheim, via Parnassus, Main Highway at Motunau, and proceeding generally in a south-easterly direction, and terminating near the mouth of the Motunau River in Section 7545, Block 15, Stonyhurst Survey District, being a distance of 11 miles, more or less. Shown on plan P.W.D. 71527, and thereon coloured red.

Hawarden-Heathstock.

All that road or portion of road in the Waipara County, commencing at its junction with the Waikari-Waitohi Main Highway at Hawarden, and proceeding generally in a northerly and westerly direction via Mason Road; thence in a south-westerly direction via Heathstock to Horsley Downs Road, and terminating opposite the northern corner of Section 9771, Block IX, Waipara Survey District, being a distance of 9 miles, more or less. Shown on plan P.W.D. 71527, and thereon coloured red.

McKenzie - Gore Bay.

All that road or portion of road in the Cheviot County, commencing at its junction with the Christchurch-Blenheim, via Parnassus, Main Highway at McKenzie, and proceeding generally in a south-easterly direction via Jed Road, and terminating at Reserve 3160, Gore Bay Village, being a distance of 5 miles 60 chains, more or less. Shown on plan P.W.D. 71528, and thereon coloured red.
