IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and of every other power and authority in anywise enabling me in this behalf, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the development of water-power (Arapuni Scheme), and I do also declare that this Proclamation shall take effect on and after the nineteenth day of May, one thousand nine hundred and twenty-eight.

APPROXIMATE area of the piece of land taken: 2 roods 28 perches.

Being portion of Section 31.

Situated in Block XII, Maungatautari Survey District (Auckland R.D.). (S.O. 23948.)
