Exempting certain Native Lands from Rates.

ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 9th day of June, 1928.

THE RIGHT HONOURABLE J. G. COATES, P.C., PRESIDING IN COUNCIL.

WHEREAS under the provisions of section one hundred and four of the Rating Act, 1925, the Governor-General may, from time to time, for the reasons therein specified exempt any Native land liable to rates from all or any part of such rates:

And whereas it is desirable that such power should be exercised in respect of the land mentioned in the Schedule hereto : Now, therefore, in pursuance of the said Act and of every other power thereunto him enabling, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby exempt the Native land named in the Schedule hereto from all rates made or levied by any local authority under the Rating Act, 1925.
