The lowest or any tender will not necessarily be accepted. A contractor is not required to convey parcel-post parcels (except express transit parcels) to offices served by rail or sea, except where the frequency of the rail or sea service is less than weekly.

Wherever possible, Government officers travelling on official business, are required to travel by mail contractors' vehicles, provided that the time-table is suitable and that

the fare charged by the contractor does not exceed that charged by the proprietor of an opposition vehicle.

A contractor, when receiving or delivering mails at railway-stations, is to deal with the guards of trains, and, if required, mails are to be placed in the railway-vans.

Tenders are to be enclosed in sealed envelopes, endorsed "Tenders for Mail-service," and are to be addressed to the Chief Postmaster of the postal district to which the tender may specially refer.
