REGULATIONS.

1. REGISTRATION under section 8 of the said Act of a copy of an order made by the Supreme Court in the exercise of its jurisdiction in divorce or other causes and matters matrimonial for the payment of any weekly or monthly amount to or for the benefit of any wife, or husband, or any child, or children, shall be effected as hereinafter provided.

2. On presentation of a copy of an order at the office of any Magistrate's Court an entry shall be made by or at the direction of a Magistrate exercising jurisdiction in that Court in the Criminal Record Book of that Court as of the day on which such copy was so presented.
