

satisfy himself that all is clear by looking to the rear of the outside of the car on the side on which passengers are boarding or alighting.

9. (1) When trailer cars are attached to "one-man" cars the number of car-conductors for the trailer cars shall be as follows:—

Use of trailers attached to "one-man" cars.

- (a) Trains consisting of a "one-man" car and one trailer car: One car-conductor.
- (b) Trains consisting of a "one-man" car and two trailer cars: Two car-conductors.

(2) No more than two trailer cars shall be used in connection to any single "one-man" car.

10. Before running "one-man" cars on the tramways such cars shall be in accordance with the deposited plans.
