## REGULATIONS.

1. These regulations may be cited as "The Fireblight Regulations, 1927, Amendment No. 2."
2. The First Schedule of the principal regulations is hereby amended by revoking the definitions of the Whangarei and Thames districts as set out therein, and substituting the following definitions:

# 1. WHANGAREI DISTRICT.

All that area in the North Auckland Land District bounded by a line commencing at the northernmost corner of Section 89, in Block V, Whangarei Survey District; thence south-easterly along the north-eastern and eastern boundaries of the said section and Reretiti Block to the stream forming
