O^N the recommendation of the Native Land Purchase Board, referred to in section three hundred and sixty-three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, and by section one hundred and eleven of the Native Land Amendment Act, 1913 (as amended by section eight of the Native Land Amendment and Native Land Claims Adjustment Act,

Prohibiting all Alienation of certain Native Land other than | 1916), His Excellency the Governor-General of the Dominion Alienation in favour of the Crown. 1916), His Excellency the Governor-General or the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council thereof, doth hereby extend for a further period of eighteen months the Order in Council dated the thirteenth day of April, one thousand nine hundred and twenty-seven, and gazetted the twenty-first day of April, one thousand nine hundred and twenty-seven, but only in so far as it affects the Native land specified in the Schedule hereto prohibiting all alienation, other than alienation in favour of the Crown.

In pursuance and exercise of the powers conferred by the Public Works Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolutions passed by the Clutha County Council on the third day of April, one thousand nine hundred and twenty-eight, and the second day of October, one thousand nine hundred and twenty-eight, respectively, the portions of roads affected by such resolutions being more particularly described in the

Schedule hereto, viz.:—
