BY virtue and in exercise of the powers and authorities conferred upon me by section eighteen of the Forests Act, 1921-22, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby set apart the Crown land described in the Schedule hereto as a permanent State forest.

SCHEDULE.

AUCKLAND LAND DISTRICT.—ROTORUA FOREST-CONSERVATION REGION.

State Forest No. 83 (Kaingaroa Plantation Extension).
(29,894 acres.)

ALL that area containing by admeasurement 29,894 acres, more or less, being Run No. 95, situated in Blocks VI, VII, VIII, X, XI, XIII, XIV, and XV, Weao Survey District, and Blocks I, II, V, and VI, Heruhi Survey District, and bounded generally as follows: Towards the east by the Wheao River, the Otupaha Stream, and a tributary, and provisional State Forest No. 59 (*Gazette*, 1920, page 2119); towards the south by Pukahunui No. 2 Block, the Otuetā Stream, the Wheao River, and again by Pukahunui No. 2 Block; towards the south-west by the aforementioned block; and towards the north-west and north by the Rangitāiki River: As the same is more particularly delineated on Plan No. 47/22, deposited in the Head Office, State Forest Service, Wellington, and thereon bordered red.
