

TAUMARUNUI COUNTY (P.W. 62/26/16.)

Roads classified in the Fourth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 4 tons :—

Te Kuiti - Bulls; Taumarunui-Okahukura; Stratford-Taumarunui; Taumarunui-Te Whakarāe; Ongarue Stream Road to Kokomiko Junction; Taringamotu Valley Road to Ngakonui Bridge.

Roads classified in the Fifth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 2½ tons :—

Stratford-Taumarunui; Te Whakarāe to county boundary; Ongarue Stream Road from Kokomiko Junction eastward; Kokomiko Road; Maungakahu Valley Road; Okahukura-Ongarue Road; Taringamotu Valley Road from Ngakonui Bridge; Lairdvale Road; Echolands Road; Pungapunga Valley Road; Ongarue River Road; Okahae Road; Kururau Road; Pongahuru Road; Otunui Road; Omaka Road; Taumarunui-Taupo Road.

TAURANGA COUNTY (P.W. 62/26/8.)

Roads classified in the Fourth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 4 tons :—

Whakatane-Tauranga Highway: (a) Length from Otamarakau to Paengaroa Junction with Te Ngae Highway; (b) length from Paengaroa Junction and Te Puke Town Board eastern boundary; (c) length from Te Puke Town Board western boundary to Papamoa Railway-station; (d) length from Papamoa Railway-station to Tauranga Borough boundary.

Te Ngae - Paengaroa Highway.

Tauranga-Matamata Highway: (a) Length from borough boundary to junction of Oropi Road; (b) junction Oropi Road to county boundary.

Tauranga-Waihi Highway: (a) County boundary to Wairoa Bridge; (b) from Wairoa Bridge to Aongatete; (c) Aongatete to county boundary.

TE KUITI BOROUGH (P.W. 62/26/111).

Streets classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

Rora Street; Carroll Street; Taupiri Street; Sheridan Street; King Street (between Carroll Street and the bridge).

Streets classified in the Fourth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 4 tons :—

Mangarino Road; Tawa Street; Esplanade; King Street (between Jennings Street and the bridge); Boundary Street; William Street; Te Kuiti Road; Ngarongo Street; Lawrence Street; Te Kumi Road; Hospital Road; George Street; Hill Street; Ward Street; Queen Street; Seddon Street; Awakino Road; Waiteto Road; King Street, from Carroll Street to South Street.

UAWA COUNTY (P.W. 62/26/36).

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

All that highway known as the Gisborne-Opotiki (via the coast) Main Highway, situated within the County of Uawa; Tolaga to Wigan Road; Tolaga to Arakihi Road; Tolaga to Tauwhareparae Road; Mangatokerau Road; Wharekaka Soldier Settlement Road; Kaiarau Road.

WAIAPU COUNTY (P.W. 62/26/113).

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

All that portion of the Main Highway running from the boundary-line between the Uawa County and Waiapu County as far as the boundary between the Matakaoa County and the Waiapu County.

WAIKATO COUNTY (P.W. 62/26/11).

Road classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

Hamilton to Eureka Hall and Piako County boundary on the direct road to Morrinsville; the section of the main highway, Ohinewai School to Ngaruawahia Borough boundary.

Roads classified in the Fourth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 4 tons :—

Hamilton to Leslie's Culvert in the direction of Cambridge; Hukanni Road from Hamilton Borough boundary to Taupiri; Tram Road, from Government Ruakura Experimental Farm to Craig's Hill; River Road from Hamilton Borough to Ngaruawahia Borough; Taupiri to Orini Cheese-factory; Tauhei Quarry to junction with Gordonton-Taupiri Road; Ohinewai to Piako County boundary at Mohring's farm on direct road to Tahuna; Ohinewai to Matahuru Stream at J. W. Mark's Farm in the direction of Taniwha.

Roads classified in the Fifth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 2½ tons :—

Ruakura Experimental Farm to Ruakura Station and to Hinton's Gully; Motumaoho Road (county boundary) to Gordonton, known as the Piako Road.

WAIKOHU COUNTY (P.W. 62/26/61).

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

Kaitaratahi to Motu (via Otoko) Road; Lavenham Road; Kanakanaia Road; Puha to Whatatutu Road; Mangatu Road; Motu Falls Road; Waikohu to Motu, via Whakarau Road; Motu Valley Road; Rakauroa to Tahora Road; Ngatapa to Wharekopae Road; Taumata Road.

WAIMAIRI COUNTY (P.W. 62/26/99).

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

McSaveney's Road, Marshland; Walter's Road, Marshland; Brigg's Road, Marshland; Reeve's Road, Marshland; Preston's Road (from Grimsey's Road to Bottle Lake Road); Bottle Lake Road, Marshland; Westminster Street, Marshland; Hill's Road (from Kelly's Road to Preston's Road); Winter's Road (from Grimsey's Road to Hill's Road).

WAIMATE WEST COUNTY (P.W. 62/26/47).

Roads classified in the First Class : Available for the use thereon of any motor-lorry :—

Main South Road; Manaia Road; Skeet Road; Normanby Road (between Manaia and Inaha Roads); Lower Auroa Road; Taikatu Road.

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

Palmer Road; Rowan Road; Mangawhero Road; Upper Auroa Road; Oeo Road; Rama Road; Glenn Road; Dingle Road; Sutherland Road; Winks Road; Inaha Road; Kokiri Road; Kearin Road; Omaturangi Road; Normanby Road (between Manaia Road to Beach).

WAIMEA COUNTY (P.W. 62/26/78).

Roads classified in the First Class : Available for the use thereon of any motor-lorry :—

Nelson-Richmond; Richmond to foot of Takaka Hill.

Roads classified in the Second Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 8 tons :—

Nelson-Lud; Richmond-Belgrove.

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

Takaka Hill; Jubilee Bridge to Mapua; Motueka to Kohatu; Wakefield to Dovedale.

Roads classified in the Fourth Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 4 tons :—

Lud to Rai Saddle; Belgrove-Glenhope.

WAIAPA COUNTY (P.W. 62/26/5).

Roads classified in the Third Class : Available for the use thereon of any motor-lorry which with the load it is carrying weighs not more than 6 tons :—

Portion of the Great South Main Highway: From the southern boundary of the Ngaruawahia Borough to the southern boundary of the Hamilton Borough.
