IN pursuance and exercise of the powers and authorities conferred upon him by the Slaughtering and Inspection Act, 1908 (hereinafter referred to as "the said Act"), and of all other powers in that behalf enabling, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, both hereby amend the regulations (hereinafter referred to as "the principal regulations") under the said Act, made by Order in Council on the fifth day of June, one thousand nine hundred and two, and published in the Gazette of the same day at page 1221, to the extent and in the manner set forth in the Schedule hereto, and doth hereby declare that this Order in Council shall come into force on the date of the publication thereof in the Gazette.

SCHEDULE.

Clause 22 of the principal regulations is hereby revoked and the following clause substituted in lieu thereof:

22. (1) The carcass of every calf, pig, kid, or lamb which, upon inspection, is found to be too immature to produce wholesome meat for human consumption shall be condemned.

(2) Any such carcass shall be deemed to be too immature to produce wholesome meat for human consumption if the

meat thereof-

- (a) Has the appearance of being water-soaked, or is loose and flabby, or tears easily, or can be perforated with the fingers.
- (b) Has a grayish colour.
- (c) Shows that good muscular development as a whole is lacking, which is especially noticeable on the upper shank of the leg, where small amounts of serous infiltrates or small edematous patches are sometimes present between the muscles.
- (d) Shows that the tissue which later develops as the fat capsule of the kidneys is edematous, dirty yellow or grayish red, tough, and intermixed with islands of fat.
- (3) All unborn and stillborn animals shall be condemned. C. A. JEFFERY.
