Alteration of Riding Boundaries.

Moved by Cr. Romayne and seconded by Cr. Fullerton-Smith:

- "In exercise of the powers conferred on it by section 23 of the Counties Act, 1920, the Ohura County Council resolves by way of special order as follows:—
 - "(1) The present division of the County of Ohura into eight ridings is revoked, and in lieu thereof the said county shall be divided into two ridings, to be called respectively Matiere Riding and Ohura Riding, which said ridings are respectively described in the Schodule broats.

"(2) The said Ohura County Council shall consist of six members, who shall be elected as follows: The electors of Matiere Riding and Ohura Riding shall each elect three councillors.

"(3) The alteration hereby made shall take effect on and after the 31st March, 1929."
