IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, the Go-vernment Railways Act, 1926, and of every other power and authority in anywise enabling me in this behalf, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes above mentioned for the purposes above mentioned.

SCHEDULE.

APPROXIMATE area of the piece of land: 3 roods 5 1 perches. Portion of Waimapihi Block, Block V, Paekakariki Survey District, Hutt County. (S.O. 2456).

In the Wellington Land District; as the same is more particularly delineated on the plan marked L.O. 178, de-posited in the office of the Minister of Railways, at Wel-lington, and thereon coloured blue.

WHEREAS by section three hundred and two of the Land Act, 1924, as amended by section ten of the Land Laws Amendment Act, 1926, it is enacted that on the disposal of any national-endowment land by way of sale, or on the acquisition of the fee-simple of any such land, the

Governor-General may by Proclamation declare that such

Governor-General may by Proclamation declare that such land shall, as from a date to be specified in the Proclamation, cease to be national-endowment land : And whereas the fee-simple of the land described in the Schedule hereto, being land heretofore held under pastoral license, has been acquired, and it is expedient that the said land should cease to be national-endowment land :

land should cease to be national-endowment land: Now, therefore, in pursuance and exercise of the powers and authorities conferred upon me by the aforesaid section three hundred and two of the Land Act, 1924, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that from and after the twentieth day of February, one thousand nine hundred and twenty-nine, the land described in the Schedule hereto, which was set apart as national-endowment land hereto, which was set apart as national-endowment land under the provisions of section two hundred and fifty-eight of the Land Act, 1908, shall cease to be national-endowment land.
