In pursuance and exercise of the powers conferred by section three of the Electric-power Boards Act, 1925, and of every other power and authority enabling me in this behalf, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim the district described in the First Schedule hereto to be an electric-power district, and I hereby assign to such district the name of the "Hurunui Electric-power District"; and I do further proclaim that the areas described in the Second Schedule hereto shall be the outer area of such electric-power district.
