Tramways No. 1 Redemption Loan, 1929, of £42,500.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Invercargill Borough Council hereby resolves as follows:—

That, for the purpose of providing the interest and other charges on a loan of £42,500, authorized to be raised by the Invercargill Borough Council under the above-mentioned Act for paying off the balance (after deducting accumulated sinking fund) of the Tramways No. 1 Loan of the Invercargill Borough of £75,000, falling due on the 1st day of April, 1930, the said Invercargill Borough Council hereby makes and levies a special rate of decimal six two six (0.626) of one penny in the pound upon the rateable value of all rateable property of the Borough of Invercargill, comprising the whole of the Borough of Invercargill, and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable yearly on the 31st day of July in each and every year during the currency of such loan, being a period of twenty years, or until the loan is fully paid off.
