RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Tahunanui Town Board hereby resolves as follows:—

That, for the purpose of providing the interest and sinking fund on a loan of £3,210, authorized to be raised by the Tahunanui Town Board under the above-mentioned Act for bituminous penetration of the main highway through the Town District, stabilizing the sea-wall, and drainage of Main Road, the said Tahunanui Town Board hereby makes and levies a special rate of one-half penny in the pound upon the capital value on all rateable property in the town district, and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable half-yearly on the first day of September and the first day of March in each and every year during the currency of such loan, being a period of fifteen (15) years, or until the loan is fully paid off.
