IN pursuance and in exercise of the powers vested in it in that behalf by the Local Authorities Empowering (Relief of Unemployment) Act, 1926, the Local Bodies' Loans Act, 1926, and the Land Drainage Act, 1908, and all other powers (if any) it thereunto enabling, the Makerua Drainage Board resolves as follows :-
