ALL that area in the Westland Land District, containing 6,400 acres, more or less, being part of Provisional State Forest Reserve 1692, situated in Blocks VI, IX, X, XI, and XV, Cascade Survey District, bounded as follows: Commencing at the north-eastern corner of Section 2530; thence following in the order and direction given lines bearing due east, 7539 links; 208°, 23200 links; 319° 51' to the Cascade Road; thence following that road in a westerly direction to its intersection with Dee Creek; thence north-easterly along a small creek to the Cascade River; thence generally in an easterly direction the southern bank of the Cascade River and the southern bank of the Laschelles Creek to Section 2530; and thence following in that order the western, southern, and eastern boundaries of that section to the point of commencement.
