#### REGULATIONS.

(1) The Commissioner shall give not less than fourteen days' public notice of the date on or before which returns of income derived from the use or occupation of lands used for agricultural or pastoral purposes if the total unimproved value of all estates or interests in such lands used or occupied at any one time during the income year was not less than seven thousand five hundred pounds (and not coming within the terms of a notice given in the form numbered 5 set out in the Schedule to the regulations made under the said Act on the 14th day of April, 1930) shall be made, and such notice shall be set forth in the form numbered 5B in the Schedule hereto.

(2) (a) Persons and companies in receipt of income which is assessable under section 4 (1) (a) of the Land and Income Tax Amendment Act, 1930, shall render returns of such income on Part D of form No. 3 as set out in the Schedule to the regulations made under the said Act on the 14th day of April, 1930.

(b) Persons and companies required to render returns under the foregoing provisions of this regulation shall also complete such other portions of the said form No. 3 as may in any case be applicable.
