RESOLUTION MAKING SPECIAL RATE.

Palmerston North Waterworks Loan (No. 2) of £14,000, 1929.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Palmerston North Borough Council hereby resolves as follows:—

That, for the purpose of providing the interest and sinking fund on a loan of £14,000, authorized to be raised by the Palmerston North Borough Council under the above-mentioned Act for the following purposes, namely:—

To enable the said Council to construct and instal one 6 in. diameter artesian well, underground cistern of 100,000 gallons capacity, to provide two electrically operated pumps, erection of pump-house, and purchase of land, and to lay 9-in. diameter mains in Ruahine Street, 12-in. diameter mains in Featherston Street, and 18-in. mains in Rangitikei Street;
