IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby revoke so much of the Proclamation dated the sixteenth day of July, one thousand nine hundred and thirty, and published in the *New Zealand Gazette*, No. 53, of the twenty-fourth day of the same month, taking land for the purposes of the Taieri Plain flood-protection works in Blocks IV and V, Maungatua Survey District, as affects the land described in the Schedule hereto.

A PROCLAMATION.

WHEREAS by a Proclamation dated the eighteenth day of December, one thousand nine hundred and twenty-nine, hereinafter termed "the said Proclamation" and published in the *New Zealand Gazette*, No. 1, of ninth January, one thousand nine hundred and thirty, page 3, the land described in the Schedule hereto was declared to be Crown land subject to the Land Act, 1924:

And whereas the said Proclamation was issued in error: Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the said Proclamation is hereby cancelled.
