IN pursuance and exercise of the powers and authorities conferred upon him by subsection one (b) of section seven of the Public Reserves, Domains, and National Parks Act, 1928, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby cancel the reservation as a reserve for the Department of Agriculture over the land described in the Schedule hereto; and doth hereby declare that the said land, being vested in the Crown, is Crown land available for disposal under the Land Act, 1924.

WHEREAS by section four hundred and fourteen, subsection one, of the Mining Act, 1926, it is provided that the Governor-General, by Order in Council, may from time to time declare that any of the provisions of the Mining Act, 1926, shall apply to prospecting and mining for and the storage of petroleum and other mineral oils and of natural gas, and also define the districts within which any such Order in Council shall take effect:

Now, therefore, in pursuance and exercise of the powers and authorities conferred on him by the said section four hundred and fourteen, subsection one, His Excellency the

Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that the provisions of the Mining Act, 1926, set out in the First Schedule hereto shall apply to prospecting and mining for and the storage of petroleum and other mineral oils and of natural gas within the district described in the Second Schedule hereto.
