Prohibiting all Alienation of certain Native Land.

WHEREAS by section one hundred and thirty-two of the Native Land Act, 1909, it is provided that for the purpose of enabling any scheme of consolidation of the

interests of owners of Native land into suitable areas to be prepared and carried into effect, the Governor-General may, by Order in Council, prohibit for a period not exceeding twelve months any alienation of Native land in respect of which application has been made by the Native Minister to the Court for the preparation of such a scheme:

And whereas an application has been made by the Native Minister to the Native Land Court for the preparation of a scheme of consolidation of the interests of the owners of the

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority hereinbefore mentioned, and acting by and with the advice and consent of the Executive Council thereof, doth hereby prohibit for a period of twelve months all alienation of the Native land specified in the Schedule hereto.
