BLEDISLOE, Governor-General. A PROCLAMATION.

WHEREAS by section one hundred and fifty-four of the Land Act, 1924, it is enacted that the Governor-General, by Proclamation, may from time to time declare any lands within any mining district to be open for disposal as provided in section one hundred and fifty-three of the said

Act:
Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, in exercise of the power and authority conferred upon me by the said one hundred and fifty-fourth section of the said Act, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the lands described in the Schedule hereto shall be open on Wednesday, the fifteenth day of July, one thousand nine hundred and thirtyone, for disposal as provided in section one hundred and fifty-three of the said Act.

Maniototo County .- Town of Hyde.

(Within boundaries of Otago Mining District.)

SECTIONS 15, 22, and 23, Block I, and Sections 9, 10, 28, 29, 33, 34, and 35, Block III, each containing 1 rood.
