The rights, powers, and privileges conferred under and by virtue of this Order in Council may be at any time resumed by the Governor-General, without payment of any compensation whatever, on giving to the company three calendar months' previous notice in writing. Any such notice shall be sufficient, if given by the Minister, and delivered at or posted to the last known address of the company in New Zealand. 12. In case the company shall—

- (1) Commit or suffer a breach of the conditions herein-before set forth, or any of them;
 (2) Cease to use or occupy the said wharf for a period of
- thirty days; (3) Fail to pay the sums specified in clause 3 of these conditions; or

(4) Be in any manner wound up or dissolved; then, and in any of the said cases, this Order in Council, and every right, power, or privilege, may be revoked and determined by the Governor-General in Council, without any notice to the company or any other proceeding whatsoever; and publication in the *Gazette* of an Order in Council con-taining such revocation shall be sufficient notice to the com-nany and to all persons accounted or interaction that this pany and to all persons concerned or interested that this Order in Council, and the license, rights, and privileges thereby conferred, have been revoked and determined.

13. The company shall be liable for any injury which may be caused at the said wharf to any vessel or boat through any default or neglect on the part of the company. 14. In the event of this Order in Council being revoked

for any reason whatsoever, or upon the expiry of the period for which the license is granted, the company shall, if required so to do, remove the said wharf entirely from the site, and restore the site to its original condition within three months from the date of the revocation or expiry, as the case may be; and if the company fails so to do the Minister may cause the said wharf to be removed and the site so restored, and may recover the costs incurred by the said removal and restoration from the company.
