

Assessors in Criminal Trials in the High Court of the Cook Islands appointed.

BLEDISLOE, Governor-General.

PURSUANT to the authority vested in me by section two hundred and ninety-five of the Cook Islands Act, 1915, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby revoke the nomination of persons qualified for appointment as Assessors in criminal trials in the High Court of the Cook Islands, made by Warrant dated the twenty-sixth day of February, one thousand nine hundred and twenty-six, and gazetted in the *New Zealand Gazette*, No. 13, of the eleventh day of March, one thousand nine hundred and twenty-six, at page 605, and made by Warrant dated the thirty-first day of July, one thousand nine hundred and twenty-six, and gazetted in the *New Zealand Gazette*, No. 52, of the fifth day of August, one thousand nine hundred and twenty-six, at page 2412, and in lieu thereof I hereby nominate the persons named in the following nine Schedules hereto as persons qualified for appointment as Assessors under the said Act generally in criminal trials in the High Court of the Cook Islands wheresoever such trials may be held (except in the Island of Niue), and I declare this Warrant to take effect on the first day of October, one thousand nine hundred and thirty-one.
