A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby revoke so much of the Proclamation dated the twenty-second day of June, one thousand nine hundred and twenty-nine, and published in the *New Zealand Gazette*, No. 48, of the twenty-seventh day of the same month, taking land for street purposes and in connection with street-widening at Thorndon Quay, in the City of Wellington, as affects the land described in the Schedule hereto, such land being no longer required for the purpose for which it was taken.
