And whereas it appears expedient to authorize the acquisition, alienation, or disposition of the land hereinafter mentioned:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority hereinbefore mentioned, and all other powers him enabling, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth

hereby authorize the acquisition, by Ngamatia Limited (a company incorporated under Part V of the Companies Act, 1908), by way of lease of the Native land mentioned in the Schedule hereto and the alienation and disposition thereof, notwithstanding the provisions of sections seventy-two to seventy-six (inclusive) of the Native Land Amendment Act, 1913, or of Part XII of the Native Land Act, 1909.
