which application has been made by a Native Minister to the Court for the preparation of such a scheme : And whereas it is provided by section eight of the Native Land Amendment and Native Land Claims Adjustment Act, 1923, that any such Order in Council may be extended from time to time :

time to time: Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority hereinbefore mentioned, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby extend for a further period of twelve months the Order in Council under the said section one hundred and thirty-two dated the first day of October, one thousand nine hundred and twenty-eight, and published in the New Zealand Gazette of the fourth day of October, one thousand nine hundred and twenty-eight, but only in so far as it affects the Native land specified in the Schedule hereto.
