N pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Rangiora County Council on the thirteenth day of March, one thousand nine hundred and thirty-one,

"The Rangiora County Council, being the local autho-rity having control of the streets in Woodend, in the Rangiora Survey District, by resolution declares that the provisions of section one hundred and twenty-eight of the

Public Works Act, 1928, shall not apply to that portion of street known as Parsonage Road, and lined red on above sketch plan, adjoining the lands in Blocks XI and XII of the Rangiora Survey District, being the lands included in Certificates of Title, Vol. 390, folio 149, Vol. 390, folio 151, and Vol. 390, folio 148";

subject to the condition that no building or part of a building shall at any time be erected on the land fronting either side of the portion of Parsonage Road (described in the Schedule hereto) within a distance of thirty-three feet from the centreline of the said portion of road.

SCHEDULE.

ALL that portion of road situated in the Canterbury Land District, County of Rangiora, known as Parsonage Road, fronting parts Rural Section 371, Blocks XI and XII, Rangi-ora Survey District. As the said portion of road is more particularly delineated on the plan marked P.W.D. 82555, deposited in the office of the Minister of Public Works at Wellington, and thereon edged red.
