Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon him by section eleven of the Harbours Act, 1923, and of all other powers and authorities enabling him in that behalf, and by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that, on and after the fifteenth day of October, one thousand nine hundred and thirty-one, the said Council shall exercise the powers of a Harbour Board within the limits of the Port or Harbour of Hokianga: And in further pursuance and exercise of the hereinbefore-recited power and authority, His Excellency, with the advice and consent aforesaid, doth hereby define the limits of the said port or harbour within which the Council of Hokianga County is to exercise the powers aforesaid as follows—that is to say: All that area of tidal land and tidal water inside the seaward are of a circle having a radius of two nautical miles from the are of a circle having a radius of two nautical miles from the signal-station on the South Head at the entrance to the said harbour.
