WHEREAS, there being no Harbour Board empowered to grant the license hereinafter mentioned, the Hobson County Council (hereinafter called "the Council," in which term is to be construed, unless the context requires a different construction, its successors or assigns) has applied to the Governor-General in Council for a license under the Harbours Act, 1923 (hereinafter called "the said Act"), to occupy a part of the foreshore and land below low-water mark at Mapuna, Northern Wairoa River, in order to erect and maintain thereon a metal landing, in accordance with plan marked M.D. 6992, and deposited in the office of the Marine Department at Wellington:

And whereas it has been made to appear to the Governor-

And whereas it has been made to appear to the Governor-General in Council that the work will not be or tend to the injury of navigation, and the said plan has, prior to the making of this Order in Council, been approved by the Governor-General in Council:

And whereas it is desirable that a license should be granted and issued to the Council under the said Act for the purpose aforesaid, on the terms and conditions hereinafter expressed:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon him by the said Act, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby of the Executive Council of the said Dominion, doth hereby approve of the purpose or object for which the said license is required by the Council as aforesaid; and, in further pursuance and exercise of the said power and authority, and with the like advice and consent as aforesaid, doth hereby license and permit the Council to use and occupy that part of the foreshore and land below low-water mark which is particularly shown and delineated on plan M.D. 6992, so deposited as aforesaid, for the purpose of erecting and maintaining thereon the said metal landing to be erected in accordance with the said plan, such license to be held and enjoyed by the Council upon and subject to the terms and conditions set forth in the Schedule hereto.

#### SCHEDULE.

#### CONDITIONS OF MANAGEMENT.

1. In these conditions the terms—
"Foreshore" means such parts of the bed, shore, or
banks of a tidal water as are covered and uncovered by the flow and ebb of the tide at ordinary spring tides:
"Low-water mark" means low-water mark at ordinary

spring tides:
"Minister" means the Minister of Marine as defined
by the Shipping and Seamen Act, 1908, and includes
any officer, person, or authority acting by or under
the direction of such Minister.

2. The concessions and privileges conferred by this Order in Council shall extend and apply to the part of the foreshore and land below low-water mark adjacent thereto necessary for the erection and maintenance of the said metal landing, at the site shown on the plan marked M.D. 6992.

3. In consideration of the concessions and privileges granted by this Order in Council, the Council shall pay to the Minister, in respect of the site for the metal landing, an annual rental of 1s., payable on demand, such rental to date from the date of this Order in Council.

4. All persons shall, at all reasonable times, and upon pay-ment of the proper dues, have free and full liberty to use the above-mentioned metal landing, and all rights of ingress and egress thereto and therefrom.

5. His Majesty or the Governor-General, and all officers in the Government service acting in the execution of their duty, shall at all times have free ingress, passage, and egress into, over, and out of the said metal landing without payment.

6. The Council shall maintain and keep the above-mentioned

metal landing and all erections on or in connection with the metal landing in good order and repair; and shall at all times exhibit therefrom, and maintain at the Council's own

cost, suitable and necessary lights for the guidance of vessels: Provided that no new light shall be exhibited until after it has been approved of by the Minister.

- 7. All dues and rates received on account of the said metal landing by the Council shall be applied to keeping the said metal landing and all erections on or in connection with such metal landing in good order and repair.
- 8. Any person authorized by the Minister may, at all reasonable times, enter upon the said metal landing and any buildings erected on the metal landing, or in connection therewith, and view the state of repair thereof; and upon the Minister leaving at or posting to the last known address of the Council in New Zealand a notice in writing of any defect or want of repair in such metal landing or buildings, requiring the Council, within a reasonable time, to be therein prescribed, to make good or repair the same, the Council shall, with all convenient speed, cause such defect to be removed or such repairs to be made.
- 9. The master of all vessels discharging ballast at the said metal landing, shall have all such ballast taken away and deposited above high-water mark, or at such place as may be approved of by the Minister, or by any person appointed by the Minister for that purpose.
- 10. The Council shall not erect, or suffer to be erected, on the said metal landing any building or structure whatever, except with the consent of the Minister.
- 11. The Council shall keep a separate account of the receipts and expenditure on account of such metal landing and premises, and shall cause such account to be balanced to the 31st day of March in every year, and shall send a copy of such account when balanced to the Minister, and shall supply any particulars in reference thereto as may be required by the Minister.
- 12. The Council shall appoint all officers necessary for th working and management of the said metal landing.
- 13. Nothing herein contained shall authorize the Council to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs, or any regulations of the Minister of Customs, or with any provisions of the Harbours Act, 1923, or its amendments, or any regulation thereunder, and that are now or may hereafter be in force.
- 14. The rights, powers, and privileges hereby conferred shall continue in force until the 12th day of December, 1941, unless in the meantime, such rights, powers, and privileges shall be altered, modified, or revoked by competent authority; and the Council shall not assign, charge, or part with any such right, power, or privilege without the previous written consent of the Minister first obtained.
- 15. The rights, powers, and privileges conferred under or by virtue of this Order in Council may be at any time resumed by the Governor-General without payment of any compensation whatever, on giving to the Council three calendar month's previous notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to the last known address of the Council in New Zealand.
- 16. The Council shall be liable for any injury which may be caused at the said metal landing to any vessel or boat through any default or neglect on the part of the Council.
  - 17. In case the Council shall-
  - (1) Commit or suffer a breach of the conditions hereinbefore set forth, or any of them; or
  - (2) Cease to use or occupy the said metal landing for a period of thirty consecutive days;

then, and in either of the said cases, this Order in Council and every license, right, power, or privilege, may be revoked and determined by the Governor-General in Council without any notice to the Council or other proceedings whatsoever; and publication in the Gazette of an Order in Council containing such revocation shall be sufficient notice to the Council and to all persons concerned or interested that this Order in Council, and the licenses, rights, and privileges thereby granted and conferred have been revoked and determined.

- 18. In the event of this Order in Council being revoked for any reason whatsoever, or upon the expiry of the period for which the license is granted, the Council shall, if required by the Minister so to do, remove the said metal landing entirely from the site, and restore the site to its original condition within three months from the date of the revocation or expiry, as the case may be; and if the Council fails so to do the Minister may cause the said metal landing to be removed and the site so restored, and may recover the costs incurred by the said removal and restoration from the Council.

### REGULATIONS.

1. These regulations may be cited as "The Cook Islands Fishing Regulations, 1931."

2. These regulations shall have no application to the Island of

It shall be unlawful for any person to use the plants known as "Rakau Papua," "Utu" (Barringtonia Butonica), or "Mataora," or any of them, in any form whatsoever, or any other form of poison or stupefying agent, in the taking or procuring of fish from any of the waters forming part of the Cook Islands:

Provided, however, that the Island Council of any island may, for the purposes of a special feast or any other extraordinary occasion, declare that "Utu" (Barringtonia Butonica), or "Mataora," or both, may be used for a fixed time and in such place or places in such island

as the Council may determine.

4. Any person who offends against the provisions of these regulations shall be liable to a fine of five pounds.

5. All fines inflicted under these regulations shall be paid into the Cook Islands Treasury, and shall form part of the public revenues of the Cook Islands.
