Declaring a Portion of Railway Reserve, at Waterloo, to be Crown Land.

A PROCLAMATION.

WHEREAS by section thirty-five of the Public Works Act, 1928, it is provided that in the case of any land taken, purchased, or acquired for a Government work, and not required for that purpose, the Governor-General may on recommendation by the Minister, by Proclamation, declare such land to be Crown land subject to the Land Act, 1924, and thereupon the land may be administered and disposed of under that Act accordingly:

Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred on me by section thirty-five of the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare the land described in the Schedule hereto to be Crown land subject to the Land Act, 1924.

And whereas the said local authority has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council under the said Act should be given to the raising of the said loan on the terms and conditions hereinafter set forth:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by the said Act, and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising by the said local authority of the said loan up to the amount of three thousand pounds, subject to the following conditions upon which the said loan may be raised:—

- (1) The term of the loan shall not exceed ten years.
- (2) The loan shall be free of interest for a period of five years from the date of the advance of the loan-moneys.
- (3) The rate of interest thereafter payable shall be at such rate or rates as shall not produce to the lender a rate exceeding the rate of four pounds per centum per annum.
- (4) The loan shall not be borrowed otherwise than on terms that the loan and the interest thereon shall be repaid by half-yearly instalments over a term of years (not exceeding five), calculated from the date on which interest first commences to accrue on any portion of the loan-moneys.

Education Act, 1914.—Amended Regulations.

IN pursuance and exercise of the powers conferred upon him by the Education Act, 1914, and of all other powers enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations amending the regulations relating to the maintenance, administration, staffing, and salaries of staffs of the secondary and technical schools combined under section two of the Education Amendment Act, 1924, as amended by section thirty-seven of the Finance Act (No. 2), 1931; and with the like advice and consent doth prescribe that this Order shall come into force on the date of the publication thereof in the *Gazette*.

REGULATIONS.

THE regulations relating to combined secondary and technical schools made by Order in Council dated 25th September, 1931, and published on page 2883 of the *New Zealand Gazette* of 1st October, 1931, are hereby amended as follows:—

1. By adding to the definition of "combined school" the words, "and shall also include the schools named in the Schedule hereto."

2. By deleting from clause 2 the words "Part IV^E, clauses 84-89 inclusive," and substituting therefor the words "Part IV^E, clauses 85-89 inclusive."

3. By inserting after clause 2 the following clause:—

"3. (1) In every combined school there shall be not more than one full-time assistant for each complete twenty-eight pupils on the roll of the school at the 1st day of March:

"Provided that where instructors are employed part time in a combined school each ten half-days of such part-time instruction shall count as the weekly service of one normal full-time assistant.

"(2) Of the equivalent full-time staff of assistant teachers employed in a combined school not more than one-sixth of the total number shall receive net salaries, excluding allowances, in excess of £354 per annum for women and £465 per annum for men, and not more than one-third net salaries, excluding allowances, in excess of £300 for women and £380 for men, the nearest whole number being taken in each case:

"Provided that, except where otherwise prescribed in these regulations, each teacher shall be paid the salary corresponding to his classification unless he be appointed, with the approval of the Director, after this regulation comes into force, to a position in which the maximum salary payable is less than that corresponding to his classification, in which case he shall receive the maximum salary corresponding to the position to which he is appointed. The Director of Education shall, on the coming into force of this regulation, require the governing body of each combined school to submit for his approval its proposals under this clause in respect of the staff of such school, and such proposals shall be subject to revision in his discretion."

4. By renumbering clauses 3 and 4 as clauses "4" and "5" respectively.

5. By inserting after new clause 5 the following clause:—

"6. The tuition fees payable by all pupils other than free-place pupils and scholarship-holders, or pupils of any lower Department, or pupils of evening classes shall be such as the Board shall determine, but shall be not less than £4 per term, reducible to £3 10s. if paid within thirty days of the commencement of the term:

"Provided that in the case of pupils attending part time for not more than eight half-days weekly, the fees may be fixed on a proportionate basis:

"Provided, further, that in the case of evening-class pupils and in the case of pupils attending for special short courses of instruction fees shall be determined in accordance with section 119 of the Education Act, 1914.

"Provided, further, that in the case of the Napier Secondary School such fees may be fixed and charged for 1931 as the Board considered reasonable, having regard to the disorganization of the schools caused by earthquakes in that year, and the Board shall have power to remit the whole or any part of the fees so determined."

FIRST SCHEDULE.

TRAINING COLLEGES.

THE regulations relating to training colleges made by Order in Council dated 13th December, 1926, and subsequently amended by further Orders in Council, are hereby further amended by revoking clause 15, and substituting therefor the following:—

15. (1) An examination, to be called the Training College Entrance Examination, shall be held every year in the month of November.

(2) The examination shall be held at such convenient centres as the Director shall from year to year appoint.

(3) Every candidate for the examination must give notice of his wish to be examined, the notice being given on a form of application provided for that purpose and procurable at the office of any Education Board. The notice must be sent so as to reach the office of the Education Department, Wellington, not later than the 8th day of September next prior to the examination, and must be accompanied by a receipt for the payment of the amount of the entrance fee as hereinafter prescribed at some money-

order office of the Post and Telegraph Department: Provided that a candidate's notice and application to be examined may be received up to the 22nd September if it is accompanied by a receipt for a late fee of one pound sterling in addition to the entrance fee.

(4) The subjects of the Training College Entrance Examination shall be—(a) Elocution, (b) Writing, (c) Freehand Drawing, (d) Blackboard Drawing, (e) English language and literature, (f) Geography, (g) History and Civics, (h) Arithmetic, (i) Algebra and Geometry.

(5) To obtain a pass in the examination a candidate will be required to show a good standard of attainment in each of the subjects prescribed in subclause (4) hereof.

(6) To obtain a partial pass in the examination a candidate will be required to show a good standard of attainment in at least seven of the subjects prescribed in subclause (4) hereof, including not less than three of the subjects: English language and literature, arithmetic, geography, history and civics.

(7) Every candidate shall enter for all the subjects of the examination which, at the time of lodging his application, are necessary for a complete pass in the examination.

(8) Any candidate who has obtained a partial pass in the examination may in any subsequent year complete the examination, provided that any candidate who requires to pass in two subjects shall enter for both subjects at the one examination. A candidate applying to be examined in two subjects under the provisions of this clause may obtain credit for one or both of the subjects taken.

(9) Any candidate who has been granted a higher leaving certificate, or who has gained an equivalent qualification, shall be exempted from examination in those subjects in which he has secured such qualification.

(10) The entrance fees for the examination shall be as follow:—

(11) Notification of the successes of candidates in the examination shall be given as soon as possible after the close of the examination, by publication in the *New Zealand Gazette*. In addition to such general notification, information shall be given to each candidate individually of his success or failure in the several subjects.

(12) The scope of the Training College Entrance Examination shall be—

(a) *Elocution*.—The reading and recitation of passages of poetry and prose. Not less than fifty lines of standard poetry should be memorized. To pass in the subject the candidate must satisfy the examiner in the following respects:—

(i) Audibility, fluency, phrasing, and expression;

(ii) Pronunciation and articulation;

(iii) Capability of showing pupils a good example of correct speech.

NOTE.—Candidates are requested to note the following directions issued to Examiners: The Examiner is requested to mark each candidate's reading under the three heads indicated above. Under the first head marks up to a maximum of thirty are to be assigned for fluency, for ability to phrase—that is, to group the words in a suitable manner—for appreciation of the value of emphasis, and for suitability of expression by intonation and by inflexion of the voice. Under the second heading marks up to a maximum of thirty are to be given for pronunciation and articulation. Under the third heading marks up to a maximum of forty are to be assigned. The placing of the accent, the articulation of the component syllables, and particularly the consonants, should receive the Examiner's careful attention.

(b) *Writing*.—Exercises in text hand, half text, and small hand, or of varied form, in such style as the candidate would adopt in setting copies for children. In the text-hand exercise the height of the smaller letters is to be the same as the space between two lines on an ordinary sheet of ruled foolscap—say, one-third of an inch. The tests given shall also include a speed test in current hand.

(c) *Freehand Drawing*.—Free drawing with pencil, pastel, or brush. The candidate will be required to draw on a quarter-imperial sheet of paper (15 in. by 11 in.) (i) a natural object or (ii) a fashioned object or a group of such objects placed before him either above or below the horizontal line of sight. The object or objects must be represented as seen from the point of view

at which the candidate may be placed. No mechanical means of measurement or execution will be allowed. The drawing, which should fairly fill the sheet of drawing-paper, should express as clearly as possible the relative proportions and positions of the several objects drawn, as well as their forms, contours, and textures.

- (d) *Blackboard Drawing*.—A practical test in blackboard drawing. In this test several alternative exercises will be given including:—
- (i) Illustration;
 - (ii) Drawing of common objects or groups of objects;
 - (iii) Sketch maps.
- (e) *English Language and Literature* (Two papers).—I (a) *Essay*: In the writing of the essay both the form and the matter are important. As regards the form, attention should be paid to the choice of words and phrases, punctuation, the division into paragraphs, and the arrangement of the material. As regards the matter, mere length is not required, but rather evidence of observation, clearness of thought, possession of ideas, and general cultivation of mind. A reasonable choice of subjects will be given.

I (b) *Language*: The main aim of the language test is to discover whether a candidate is able to appreciate and use good English. Candidates may be required to express in their own words a passage of moderately difficult English, or to summarize its meaning in a précis. They may also be asked to explain the meaning and use of particular words and idiomatic expressions that are in common use. A knowledge of the elements of English grammar will be expected, and a test in analysis and synthesis may be given.

II *Literature*: This section is intended to be a test not of one year's work of special preparation, but rather of the reading that has been covered during the two or three years preceding the examination. Candidates should remember that the results of their reading will be tested not only under this section, but under all three sections of this syllabus. Candidates will be expected to answer general questions on such plays of Shakespeare and such works of standard authors, including modern novelists and poets, as may from time to time be prescribed. Questions on literary appreciation will be included.

- (f) *Geography*.—(i) Physical and mathematical geography, as follows: The approximate size and form of the earth; its daily rotation; the north and south line; latitude and longitude, meridians and parallels, local time; annual revolution of the earth round the sun; the altitude of the sun at the equinoxes and at the solstices; the inclination of the earth's axis to the plane of its orbit; the length of the day; determination of latitude and longitude; the zones, the seasons, winds, currents, trade winds, monsoons, weather changes. Rainfall and its distribution; controlling factors. Temperature; its distribution; isotherms. Different types of climate; climatic regions of the world. Connection between temperature, moisture, and resultant vegetation. Variation of vegetation with altitude and latitude. Typical animal-life in different parts of the earth. Distribution of industries and products as controlled by physical conditions. The work of rain, rivers, ice, wind, and sea. Scales of maps; contours; easy map-reading. Methods of map projection (Mercator's, equidistant and conical).
- (ii) The physical, political, and economic geography of the British Empire and of the lands bordering upon the Pacific, with special reference to New Zealand and its dependencies.
- (iii) A regional study of the geography of the rest of the world (including great geographical discoveries and the chief trade routes of the world).

(g) *History and Civics*.—A general course of British history, in which the following shall be the main topics:—

Social life in Britain during Roman, Saxon, Danish, and Norman times. The Church of the Middle Ages and the influence of the monasteries. The chief characteristics of the age of chivalry and leading figures connected with the period—the Crusades. The break-up of the manorial system and the growth of the towns. The addition of Wales, Scotland, and Ireland to the English Crown. Great Britain's share in the Renaissance and the Reformation. The early explorations of America—the

struggle with Spain under Elizabeth. The chief points of conflict between King and people during the struggle with the Stuarts. Great Britain's colonies in America, and her struggle to retain them. Industrial developments of the eighteenth and nineteenth centuries. Chief humanitarian movements of the same period. Parliamentary reform. French Revolution. British colonial expansion in South Africa and in India, in brief outline. Foundation and settlement of Australia—leading features in the history of New Zealand. Efforts to secure the peace of the world—League of Nations.

Citizenship: Based on the work prescribed in the Syllabus of Instruction for Public Schools.

- (h) *Arithmetic*.—Numeration and notation; fundamental rules; factors and multiples; compound quantities; metric system and decimal fractions; decimal approximations; vulgar fractions; unitary method, ratio, and proportion; percentages; profit and loss; simple interest, compound interest, and bankers' discount; rates, taxes, and premiums; shares and stocks; exchange (simple cases); partnerships; bankruptcies; averages; square root; cube root of numbers reducible to prime factors not greater than 11; areas of plane rectilinear figures and of circles; mensuration of the prism, pyramid, sphere, circular cylinder, and circular cone.

In the solution of problems dealing with the metric system the operations will involve only such denominations as are commonly used in actual life. Full use should be made of rough preliminary estimates, and these, where made, should be shown. Special importance will be attached to orderly and logical setting-out of work, and consideration will be given also to choice of method where such selection is possible. Candidates are at liberty to make free use of algebraical symbols and processes, of graphical methods, and of logarithms.

- (i) *Algebra and Geometry*.—Algebra: Fundamental operations, factors, fractions, simple equations involving one or two unknown quantities, and easy quadratic equations involving one unknown quantity; easy problems; graphs of simple rational integral algebraic functions; and graphical methods of solving equations. Geometry: The paper in geometry will contain questions on practical and on theoretical geometry. Every candidate will be expected to answer questions in both branches of the subject:—

(1) *Practical.*

Bisection of angles and of straight lines. Construction of perpendiculars to straight lines. Construction of an angle equal to a given angle. Construction of parallels to a given straight line. * Simple cases of the construction from sufficient data of triangles and quadrilaterals. * Divisions of straight lines into a given number of equal parts or into parts in any given proportions. Construction of a triangle equal in area to a given polygon. Construction of a square equal in area to a given polygon. * The construction or plotting of the loci of points subject to simple geometrical conditions. * Determination by measurement of the ratio of the circumference of a circle to its diameter. * Approximate determination of the area of a circle. Construction of tangents to a circle and of common tangents to two circles. * Simple cases of the construction of circles from sufficient data. * Construction of a fourth proportional to three given straight lines and a mean proportional to two given straight lines. * Construction of regular figures of three, four, six, or eight sides in or about a given circle.

No formal proofs will be required of the constructions marked *. Every candidate must provide himself with a ruler graduated in inches and tenths of an inch and in centimetres and millimetres, set squares, a protractor, compasses, and a fine pencil. All figures should be drawn accurately.

(2) *Theoretical.*

The following theorems, together with questions upon them, easy deductions from them and arithmetical illustrations:—

Angles at a Point:—

If a straight line stands on another straight line, the sum of the two angles so formed is equal to two right angles; and the converse.

If two straight lines intersect, the vertically opposite angles are equal.

Parallel Straight Lines :—

When a straight line cuts two other straight lines, if—

(i) A pair of alternate angles are equal; or

(ii) A pair of corresponding angles are equal; or

(iii) A pair of interior angles on the same side of the cutting-line are together equal to two right angles—

then the two straight lines are parallel; and the converse.

Straight lines which are parallel to the same straight line are parallel to one another.

If there are three or more parallel straight lines, and the intercepts made by them on any straight line that cuts them are equal, then the corresponding intercepts on any other straight line that cuts them are also equal.

Triangles and other Rectilinear Figures :—

The sum of the angles of a triangle is equal to two right angles.

If the sides of a convex polygon are produced in order, the sum of the angles so formed is equal to four right angles.

If two triangles have two sides of the one equal to two sides of the other, each to each, and also the angles contained by those sides equal, the triangles are congruent.

If two triangles have two angles of the one equal to two angles of the other, each to each, and also one side of the one equal to the corresponding side of the other, the triangles are congruent.

If two sides of a triangle are equal, the angles opposite to these are equal; and the converse.

If two triangles have the three sides of the one equal to the three sides of the other, each to each, the triangles are congruent.

If two sides of a triangle are unequal, the greater side has the greater angle opposite to it; and the converse.

Of all the straight lines that can be drawn to a given straight line from a given point outside it, the perpendicular is the shortest.

The opposite angles of a parallelogram are equal; and the converse.

The opposite sides of a parallelogram are equal and each diagonal bisects the parallelogram; and the converse of the first part.

The diagonals of a parallelogram bisect one another; and the converse.

If a pair of opposite sides of a quadrilateral are equal and parallel, it is a parallelogram.

The straight line drawn through the middle point of one side of a triangle parallel to another side bisects the third side.

The straight line joining the middle points of two sides of a triangle is parallel to the third side and equal to one-half of it.

Areas :—

The area of a rectangle is measured by the product of the measures of its sides.

The area of a parallelogram is equal to the area of a rectangle on the same base and between the same parallels, and is therefore measured by the product of the measures of its base and its altitude.

Parallelograms on the same or equal bases and of the same altitude are equal in area.

The area of a triangle is equal to one-half of the area of a rectangle on the same base and between the same parallels, and is therefore measured by one-half of the product of the measures of its base and its altitude.

Triangles on the same or equal bases and of the same altitude are equal in area.

Equal triangles on the same or equal bases are of the same altitude.

The square of the hypotenuse of a right-angled triangle is equal to the sum of the squares on the other two sides; and the converse.

Geometrical proofs of the following algebraic identities :—

$$k(a + b + c) = ka + kb + kc$$

$$(a + b)^2 = a^2 + 2ab + b^2$$

$$(a - b)^2 = a^2 - 2ab + b^2$$

$$a^2 - b^2 = (a + b)(a - b)$$

The square on a side of a triangle is greater than or less than the sum of the squares on the other two sides, according as the angle contained by those sides is obtuse or acute. The difference is twice the rectangle contained by one of the two sides and the projection on it of the other.

Loci :—

The locus of points equidistant from two fixed points is the perpendicular bisector of the line joining the two fixed points.

The locus of points equidistant from two intersecting straight lines consists of the pair of straight lines which bisect the angles between the two given lines.

The Circle :—

A straight line, drawn from the centre of the circle to bisect a chord which is not a diameter, is at right angles to the chord ; conversely, the perpendicular to a chord from the centre bisects the chord.

There is one circle, and one only, which passes through three given points not in a straight line.

In equal circles (or in the same circle), (i) if two arcs subtend equal angles at the centres, they are equal ; (ii) conversely, if two arcs are equal, they subtend equal angles at the centre.

In equal circles (or in the same circle), (i) if two chords are equal, they cut off equal arcs ; (ii) conversely, if two arcs are equal, the chords of the arcs are equal.

Equal chords of a circle are equidistant from the centre ; and the converse.

The tangent at any point of a circle and the radius through the point are perpendicular to one another.

If two circles touch, the point of contact lies on the straight line through the centres.

The angle which an arc of a circle subtends at the centre is double that which it subtends at any point on the remaining part of the circumference.

Angles in the same segment of a circle are equal ; and, if the line joining two points subtends equal angles at two other points on the same side of it, the four points lie on a circle.

The angle in a semicircle is a right angle ; the angle in a segment greater than a semicircle is less than a right angle ; and the angle in a segment less than a semicircle is greater than a right angle.

The opposite angles of any quadrilateral inscribed in a circle are supplementary ; and the converse.

If a straight line touch a circle, and from the point of contact a chord be drawn, the angles which this chord makes with the tangent are equal to the angles in the alternate segments.

If two chords of a circle intersect either inside or outside the circle, the rectangle contained by the parts of the one is equal to the rectangle contained by the parts of the other.

Any proof of a proposition will be accepted which appears to the examiners to form part of a systematic treatment of the subject : the order in which the theorems are stated is not imposed as the sequence of their treatment.

In the proof of theorems and deductions from them, the use of hypothetical constructions will be permitted. Proofs which are applicable only to commensurable magnitudes will be accepted.

SECOND SCHEDULE.

EXAMINATION AND CERTIFICATION OF TEACHERS.

THE regulations relating to the examination and classification of teachers made by Order in Council dated 13th February, 1912, and subsequently amended by several Orders in Council, are hereby revoked, and the following substituted therefor :—

CERTIFICATES : GENERAL CONDITIONS.

1. Certificates distinguished from the highest to the lowest by the letters A, B, and C shall be issued by the Director of Education to teachers on production of evidence of academic attainment and professional skill.

2. A certificate of Class D, as provided in the regulations for the examination and classification of teachers in force prior to the date of the operation of this Order (hereinafter called the former regulations), shall be issued to any teacher who under the provisions of the former regulations has already passed the examination for Class D, or who, having already fulfilled the requirements of the examination for Class D, except in respect of not more than two of the subjects prescribed, furnishes to the Director, by examination, evidence of his attainment in the deficient subjects of at least as high a standard as was required for a certificate of Class D under the former regulations.

3. No teacher's certificate shall be issued until the Director is satisfied that the applicant has shown such ability to teach as would warrant the issue of a certificate, or until the applicant has produced evidence—

- (a) That he has attained the age of nineteen years :
- (b) That he is of good moral character :
- (c) That he is of sound health and good constitution, and that he is free from all such physical defects as are in the opinion of the Director incompatible with efficiency in teaching :
- (d) That he has reached a standard of academic attainment deemed under these regulations to be sufficient for the purpose.

The evidence of age submitted shall, if possible, be a Registrar's certificate of birth. In the case of an applicant by whom a Registrar's certificate of birth is not procurable, the Director shall decide what other documentary evidence of age and identity may be accepted instead of such certificate.

As evidence of good character, testimonials of recent date must be presented from not less than two persons of approved standing and repute.

In proof of health and freedom from physical defects a satisfactory medical certificate secured by the applicant when appointed as a probationer may in general be accepted as sufficient ; but when a special medical examination is required the fee for such examination shall be paid by the applicant. No medical certificate shall be regarded as sufficient unless it is on a form provided for the purpose and is signed by the medical officer appointed therefor by the Director.

4. (1) Every candidate for a teacher's certificate shall be required to submit evidence of having passed either an examination held in accordance with these regulations or an equivalent examination held by some sufficient public authority.

(2) A partially equivalent examination or other evidence of qualification may be recognized *pro tanto*, and supplemented by such further examination as may be deemed necessary by the Director, who shall be the judge of the value to be assigned to examinations or qualifications proposed for acceptance as equivalent or partially equivalent.

(3) Nothing in these regulations shall be taken to forbid the issue of a teacher's certificate and the endorsement of such certificate in accordance with clauses 22 and 23 of the Regulations for Training Colleges.

RECOGNITION OF OVERSEAS CERTIFICATES.

5. Subject to the provisions of the preceding clause, a teacher holding a teacher's certificate issued by a recognized public authority outside the Dominion may, if the Director is satisfied of the sufficiency of the qualification, be granted a certificate of the class which in the opinion of the Director is equivalent to the class of the certificate held by such teacher. In any such case, until the evidence submitted is confirmed after reference to the public authority concerned, a provisional certificate may be granted, and may at any time be revoked.

SPECIAL CERTIFICATES.

6. On such terms as the Minister of Education may from time to time determine special certificates may be granted to properly trained persons who have shown sufficient ability in the teaching of individual subjects of primary, secondary, or technical instruction, or in the teaching of defective children or in kindergarten work, whether such persons hold an ordinary teacher's certificate or not. In lieu of such special certificate an endorsement may be made on any certificate already held.

FORM OF CERTIFICATE.

7. Every certificate issued to an applicant shall be on a form approved by the Minister, and shall provide for endorsements showing the special qualifications of the holder.

FEE FOR CERTIFICATE.

8. On the issue of a certificate a fee of £1 shall be payable.

DUPLICATE CERTIFICATES.

9. No duplicate certificate shall be issued to any person unless the certificate already held by him shall have been surrendered, or unless conclusive evidence to the satisfaction of the Director shall have been given that the certificate has been destroyed or irretrievably lost. For any such duplicate certificate issued a fee of 10s. shall be payable.

ACADEMIC REQUIREMENTS FOR CERTIFICATES.

10. The following shall be the academic requirements for the award of certificates of Class A, Class B, and Class C :—

- (1) *Class A*.—An applicant for a certificate of Class A shall either—
- (a) (i) Have gained at an Honours Examination of the University of New Zealand such success as is required for Honours, but with no limit as to the time of passing such Honours Examination, and without the obligation of obtaining a degree, or have passed the examination for a Bachelor's degree in arts and for a Bachelor's degree in some other faculty approved by the Director; and
 - (ii) Have secured a pass for the Diploma of Education; or
 - (b) Have fulfilled the following conditions, namely, he must—
 - (i) Hold a teacher's certificate of Class B;
 - (ii) Be adjudged by the Director to be a "very good" or "excellent" teacher;
 - (iii) Have had ten years' service in permanent positions as a full-time teacher in New Zealand schools subject to inspection by the Education Department; and
 - (iv) Have submitted to the Director a thesis of sufficient merit embodying the result of original work in some approved educational subject.
- (2) *Class B*.—An applicant for a certificate of Class B shall either—
- (a) Have obtained a Bachelor's degree in arts or science or in some other faculty approved by the Director and have also at the Class C Examination conducted by the Education Department passed in principles and practice of teaching, in school and personal hygiene, and in two other Class C subjects which he has not passed for the Bachelor's degree; or
 - (b) Have obtained a Class C certificate and have also been credited with not less than six units in at least three subjects at the examination for the Degree of Bachelor of Arts in the University of New Zealand, or with not less than five units in at least two subjects at the examination for the Degree of Bachelor of Science in the University of New Zealand.
- (3) *Class C*.—An applicant for a certificate of Class C shall be required—
- (a) To pass the Training College Entrance Examination;
 - (b) To pass in the compulsory subjects of Part I of the Class C Examination Schedule;
 - (c) To pass in two subjects selected from Division I of Part II of the Class C Examination Schedule, and in the case of men two subjects, and in the case of women one subject, from Division II of the same schedule; and
 - (d) To furnish evidence by means of a certificate signed by an approved authority that he has completed, in accordance with the regulations, a course of practical work where such is required in the science subjects selected for the purpose of this examination, such course to be completed not later than the 31st day of January of the year following the date of the examination.

Thesis for Class A Certificate.

11. The following shall be the conditions relating to the thesis for a Class A Certificate:—

- (i) The thesis shall be submitted in triplicate to the Director during the month of August in any year.
- (ii) The thesis shall be accompanied by a synopsis of the bibliography of the subject.
- (iii) The thesis shall first be submitted by the Director to three Inspectors of the Education Department. Unless a majority of such Inspectors recommend to the contrary, the thesis shall then be submitted to an examiner selected by the Director.
- (iv) The Examiner shall make a written report to the Director, stating whether in his judgment the work of the candidate is a contribution to education of sufficient value to entitle the candidate to a certificate of Class A, and is not merely a compilation of reports or opinion of other people.
- (v) If the Examiner is of opinion that the thesis possesses merit, but does not entitle the candidate to a certificate of Class A, he may recommend the Director to permit the candidate in question to resubmit his thesis in a revised form.
- (vi) The fee for the examination of a thesis shall be five guineas, and for the examination of a thesis that is resubmitted half the ordinary fee.

SCHEDULE OF EXAMINATION SUBJECTS.

12. The schedule of subjects for the Class C Examination shall be—

Part I (Compulsory Subjects).

- (1) Education.
- (2) English Language.
- (3) English Literature.
- (4) Principles and Practice of Teaching.
- (5) School and Personal Hygiene.
- (6) Music.
- (7) Needlework (for women only).
- (8) Drawing (Freehand and Blackboard).
- (9) Physical Education.

Part II (Optional Subjects).

Division I—

- (10) Geography, including Physiography and Economic Geography.
- (11) Agriculture and Dairy Science.
- (12) Physical Science.
- (13) Chemistry or Domestic Science.
- (14) Biology or Botany.

Division II—

- (15) Latin.
- (16) French.
- (17) Pure Mathematics.
- (18) Psychology or Experimental Pedagogy.
- (19) History.
- (20) School Handwork.
- (21) Woodwork and Metalwork.

CONDITIONS GOVERNING THE EXAMINATION.

13. Candidates may take the subjects of the examination in any order and in any number, except that not more than one subject may be taken from Part II in addition to those that are required to complete the examination.

14. Exemption from examination in any subject for Class C may be obtained—

- (1) By passing in that subject at a degree examination recognized by the University of New Zealand:
- (2) By gaining not less than 45 per cent. of the possible marks in that subject at the Entrance Scholarship Examination of the University of New Zealand:
- (3) By passing in that subject at any other examination approved for this purpose by the Director.

15. A candidate who satisfies the Director that he is unable on account of natural defects to comply with the requirements in vocal music may be permitted to substitute for the subject Music (6) a subject selected from Part II of the examination schedule.

16. Candidates shall be credited with passes in individual subjects, except in the Training College Entrance Examination, in which credit shall be given only for a full pass or for a partial pass, as defined in clause 15 of the Regulations relating to Training Colleges.

DATE OF EXAMINATION AND EXAMINATION CENTRES.

17. The examination of candidates for Class C certificates shall be held every year in the month of August or September commencing, in general, during the last fortnight in August. The examination shall be held at such convenient centres as the Director shall from year to year appoint.

NOTICE OF CANDIDATURE: ENTRANCE FEE AND LATE FEE.

18. (1) Every candidate shall give notice of his wish to be examined, the notice being given on a form of application provided for that purpose and procurable at the office of any Education Board. The notice shall be sent so as to reach the office of the Education Department, Wellington, not later than the 30th day of June before the examination, and shall be accompanied by a receipt for the payment of the amount of the entrance fee as hereinafter prescribed. Such fee shall be paid to the Public Account at any branch of the Bank of New Zealand or, where there is no such branch, into a money-order office of the Post and Telegraph Department.

(2) The fee payable for the Class C Examination shall be 15s. for each subject, provided that the maximum fee payable at any one examination shall not exceed £3 15s.

(3) Candidates shall, at the time of making application to be examined, say at which centre they wish to present themselves. They may afterwards up to the end of the second week in July elect to be examined at some other centre upon payment of an additional fee of 10s.

(4) Notwithstanding anything contained in subclause (1) hereof, a candidate's notice and application to be examined may be received up to the end of the second week in July if it is accompanied by a receipt for a late fee of £1 in addition to the entrance fee.

NOTIFICATION OF RESULTS.

19. Notification of the successes of candidates at any certificate examination shall, as soon as possible after the close of the examination, be given by publication in the *New Zealand Gazette*. In addition to such general notification, information shall be given to each candidate individually of his success or failure in the several subjects.

SCOPE OF CLASS C EXAMINATION.

20. The scope of the examination in the several subjects for the certificate of Class C shall be as follows:—

Part I (Compulsory).

(1) *Education (Two Papers)*.—A. History of Education (two-hour paper): The nature and scope of education. Typical definitions and modern conceptions of education. A general knowledge of the educational movements associated with the following: Rousseau, Pestalozzi, Herbart, Froebel, Spencer, Armstrong, Montessori, Dewey, Binet, Nunn.

B. Foundation of Education, including Educational Psychology (three-hour paper): Education in relation to the development of the race, the individual, and society—that is, education in relation to life. The chief physiological and psychological characteristics of the infant, the child, and the adolescent. The theory of play; the play-way in education. Doctrines of interest and formal discipline. Fatigue. Heredity and environment as influencing a child's development. General intelligence and its measurement. Imitation and suggestion. Habit and instinct. Association, memory and imagination. Reasoning.

(2) *English Language* (three-hour paper).—Candidates will be required—

(a) To give evidence of a competent knowledge of the English language, including—

(i) Some acquaintance with the history of the language. Candidates will be expected to know something of the making of English grammar, the growth of English vocabulary to the present day, and the great makers of English;

(ii) An adequate working-knowledge of phonetics:

(b) To display ability to write good English.

The examination will consist of (a) questions on the English language, including phonetics; (b) an essay on a subject selected from a number of alternatives, some of which have reference to the literature studied.

(3) *English Literature* (three-hour paper).—Candidates will be required—

(a) To show a satisfactory knowledge of English literature based upon a general survey from 1579 to the present day. This survey shall include a study of the principal literary movements and their leaders; a short treatment of the origin and development of the drama; the evolution of the English novel; the main streams of romantic and classical poetry; acquaintance with modern poetry:

(b) To be familiar with the broad principles on which children's literature should be selected and studied:

(c) To answer questions on such books as from time to time may be prescribed.

(4) *Principles and Practice of Teaching* (three-hour paper)—(a) A knowledge of the primary school syllabus and of the general methods of teaching the various subjects therein. Preparation of time-tables, schemes of work, and daily programmes. The rural one-teacher school—its problems and management.

(b) The principles upon which methods of teaching should be based. A knowledge of commonly accepted class-room methods as well as the more recent developments in educational practice, organization, and management of the school and classroom—e.g., various forms of classification, group work, individual work. Preparation of oral lessons; methods of questioning. Methods of securing the co-operation of the pupil in the process of education. Discipline as a school problem. Methods of teaching specially applicable to (i) the preparatory classes with special reference to Froebel and Montessori, and (ii) the higher classes. Educational value and right use of handwork. Use of illustrative media and concrete expression.

(c) Registers and returns. Examination and classification of pupils. Duties of the teacher in relation to the parents, the School Committee, and the Board. A knowledge of the compulsory-attendance sections of the Education Act.

(5) *School and Personal Hygiene* (three-hour paper)—(a) The school: Site; water-supply, drinking facilities; sanitary arrangements; cleaning, general sanitation and drainage. Ventilation, heating, and lighting. Furniture; cloakrooms. Play-ground. Open-air instruction.

(b) Nutrition: Classification, relative value and digestibility of food-stuffs; general principles of diet; standard diets; care and preservation of foods; putrefaction and fermentation; parasites introduced into food; adulteration of foods and methods of detecting same. General composition and dietetic value of different foods. Vitamins, condiments, and beverages. Tobacco and alcohol. Malnutrition, nutrition index.

(c) Personal hygiene: Clothing; cleanliness; baths; exercise; care of eyesight; rest; sleep.

(d) Welfare and Health of Children: Children's ailments, diseases; infection; precautions against the spread of disease in the school, and among the community; closing of schools. Relationship between school life and the responsibility of the teacher; conditions controllable by the teacher with particular reference to the care of the hair, teeth, and skin. The school lunch. Medical inspection of school-children; school clinics; care of special children (retardates, defectives, &c.).

(e) First Aid: Artificial respiration and its application in cases of drowning or suffocation; treatment of cuts, wounds, sprains, fainting, burns, scalds, bites, stings, and poisoning; first aid in cases of broken bones, insensibility, sudden illness, or collapse; methods of lifting, bandaging, and conveying the sick or injured; the selection and application of anti-septics and disinfectants.

A candidate in school and personal hygiene will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work occupying at least thirty hours and including an approved course in first aid and ambulance work.

(6) *Music*.—(a) Theory of Music (two-hour paper): Notation—(i) Sol-fa notation. The sol-fa names of the degrees of the diatonic scale, with *fe* and *ta*. Pulses and pulse marks—strong, weak, and medium; half-pulse, quarter-pulse, thirds of a pulse; continuations and silences, with time-names for the same. Bar-lines, the brace, and double bar. Key-indications. Octave-marks. Transitions, bridge-notes, and distinguishing-tones; chromatics; the *lah* mode or minor scale.

(ii) Staff notation—Treble and bass clefs; sharp, flat, and natural; key-signatures. Semibreve, minim, crotchet, quaver, semiquaver, and corresponding rests. Tied notes; triplets; the dot after a note. Time-signatures. Correct writing of note-stems and heads, clefs, accidentals, &c., and grouping of notes according to time-signatures; all key-signatures and time-signatures; minor scales, harmonic and melodic, with position of semitones; double sharp and double flat.

Musical terms and signs: Those most commonly in use.

Methods of teaching: Breathing and voice; ear-training; rhythmical movement; theory and sight-singing; as outlined in the Department's "Scheme of School Music."

Songs: Acquaintance with the following songs named in Appendix I of "Scheme of School Music"—Unison (very easy), those from "Dominion Song Book"; unison (easy), those from "English Folk Songs for Schools"; unison (moderately easy), those from "The Shanty Book, Part I," first six mentioned; unison (moderately difficult), those from "Novello's Classical Songs, Book 4." Selection, with examples, of suitable songs for different standards. Method of teaching songs.

Musical invention: Composition of a melody to fit a short verse of poetry.

Musical appreciation: General questions on "The Complete Book of the Great Musicians." Percy Scholes (Oxford University Press). Use of the gramophone in schools on lines laid down in the "Scheme of School Music."

(b) Practical Vocal Tests: Scales.—The singing of major and minor (harmonic and melodic) scales; one of each scale, ascending and descending, to be sung to "laa" or tonic sol-fa syllables.

Ear Test: A simple test consisting of short phrases in 2/4, 3/4, 4/4, or 6/8 time, to be imitated from the examiner's pattern; note-values to range from semibreve to semiquaver; rests and dotted notes may be included; no interval, with exception of octave, to exceed a major sixth; three or four short phrases to be given, one of which may be in the minor key; candidates may be asked to write down in sol-fa a phrase of four or five notes from the major diatonic scales, the *doh* being given by the examiner.

Time : Time tests of a few measures to be sung on one note or to tonic sol-fa time names to examiner's counting or beat ; dotted notes, rests, the tie or bind, and the pause may be included ; note values and times as mentioned for the ear test ; distinct tests for each notation may be given. The candidate may be required to show the correct method of beating time to songs he has prepared for the tune tests specified below.

Tune : The candidate will be required—

- (i) To sing a verse of each of two songs of his own selection from the lists quoted above. Marks will be given for choice. Candidates must be prepared to sing with or without accompaniment.
- (ii) To sing to sol-fa syllables a melody written in staff notation and supplied by the examiner. This may be in any key, major or minor, and may contain transitions to nearest keys, also accidentals. The key-chord will be sounded by the examiner.

Viva voce questions on the notation, &c., of the tests given may be asked at the discretion of the examiner.

NOTE.—Candidates who have obtained the certificates of the Associated Board of the R.A.M. and the R.C.M. in the Advanced Grade Vocal Examination, or the certificates of the Trinity College, London, in the High Local Vocal Examination, or have obtained diplomas in vocal music from the above colleges, will be exempt from the practical test.

(7) *Needlework* (three-and-a-half-hour paper).—The requirements of the examination shall be based on the syllabus set out on pages 52-54 and pages 193-195 of the syllabus of instruction for public schools. It will include a study of the following :—

(i) Materials : The selection and preparation of suitable cloth and accessories for classes from Standard I to Form II ; the price, width, wearing qualities, &c., of the various materials contrasted and compared ; the importance of obtaining suitable needles and cottons to correspond with the various materials and types of articles under construction ; the possibilities of obtaining suitable materials for small articles economically—*i.e.*, costing little or nothing.

(ii) Stitches and processes : A knowledge of all the stitches used in plain sewing with special attention to their beginnings, joins, and finishes ; repairing of garments, of house and table linen ; the artistic and economic value of simple stitches used for the purpose of construction and decoration *combined*, especially in the work of junior classes.

(iii) Patternmaking : The drafting of simple patterns such as would be used in any primary-school class ; cutting out "by proportion" ; adaptation of a commercial pattern to various figures ; method of placing and cutting out garments to avoid waste.

(iv) Colour and simple design : Preparation of designs ; colours to be employed considered in relation to the design and decoration of the article.

(v) Knitting : Suited to the needs of the various standards—*e.g.*, for Standard I, a doll's bonnet ; for Standard VI, a baby's sock.

The answering of questions on needlework considered as an educational system, as well as a utilitarian subject, will form part of the paper. Candidates must bring to the examination a thimble, scissors, needles of several sizes, pins, white sewing-cotton No. 50, tape measure, ruler, and coloured pencils.

(8) *Drawing*.—(a) Freehand (one-and-a-half-hour paper), and (b) Black-board (three-quarter-hour paper) for three tests : The standard of attainment required for a pass in this subject will be more advanced than that required in the Training College Entrance Examination.

(9) *Physical Education* (two-hour paper).—(a) Elementary Physiology : The skeleton ; structure and mechanics of the principal joints. Principal muscles. Ligaments, tendons, cartilage. Circulatory and respiratory systems. The skin and its functions. The alimentary canal.

(b) The Recognized Manual of Physical Education : History of physical education. Principles of physical education. Principles underlying the construction of tables of exercises and application of same. Principal physical defects. Importance of medical advice in applying corrective measures. Recognition of major defects—*e.g.*, spinal curvature, flat foot, flat chest, rounded shoulders, knock-knees. Signs of physical weakness ; fatigue. Corrective treatment ; exercises ; rest. (Mr. J. Renfrew White's Manual.)

Every candidate shall produce a certificate showing that he has sufficient knowledge to teach the following :—

(c) Folk and Country Dancing : At least three dances of each kind ; knowledge of terms, steps ; ability to demonstrate.

(d) Games : (i) Organized games—at least six games to be known, including three singing games. (ii) Field games—One of the following : Cricket, tennis, football, hockey, basketball ; badminton.

(e) Swimming and Life-saving: The rescue drill on land; the release drill on land; the drill for the Schafer method of resuscitation; the drills for rescue in the water, second and fourth methods, together with one method of release. In the rescue methods the subject shall be carried a distance of not less than ten yards. Object diving from the surface of the water, or from the side of the bath, preferably the former. Swimming a distance of not less than 50 yards breast stroke and 25 yards back stroke.

Candidates holding the "elementary certificate" of the Royal Life-saving Society, or its equivalent, shall be exempt from any test in swimming and life-saving. In exceptional circumstances a candidate may be exempted by the Director from qualifying in swimming and life-saving.

Part II (Optional Subjects).

Division I.

(10) *Geography, including Physiography and Economic Geography* (three-hour paper).—(a) The earth as a globe: Size, shape, and general structure; motions of rotation and revolution and their effects—*e.g.*, day and night; seasons. The earth as a member of the solar system: Inclination of the earth's axis and its effects; meridians and parallels; latitude and longitude; measurement of time; the construction and use of maps; projections (equidistant, conical, and Mercator's only); rhumb-line and great-circle sailing.

(b) The Atmosphere: Composition; distribution of pressure; isobars and barometric gradient; seasonal changes of temperature; isotherms; winds; planetary circulation; trade winds, &c.; cyclones and anticyclones; monsoons, &c.; rainfall, its cause and seasonal distribution; rainy and dry belts; climate; factors of irregular distribution of land and water; climatic control over forms of vegetation; meteorological instruments; weather records; interpretation of weather charts; principles of weather forecasting.

(c) The Ocean and its Work: Form of ocean basins; composition temperature, and pressure of ocean-water; waves, currents, tides; processes at work on shore-lines; effect of earth-movements in modifying coasts, especially as regards their effect on human activities; special attention to the influence of the oceans on the life of man.

(d) The Land: Stratified and unstratified rocks; causes and effects of weathering; the work of running-water; work of destruction; corrosion, carving out of land-forms, &c.; transportation; removal of waste; work of construction; such aggradational forms as flood-plains, terraces, alluvial-fans, deltas; the cycle of erosion; its importance in systematizing the study of land-forms; initial, consequent, and subsequent drainage features; influence of geological structure on development of land-forms; stages in the cycle of geographic development; complications of geographic cycle due to differential movements of earth's crust; work of ice; glaciers; erosion forms of mountain or valley glaciers; moraines; importance to man of the work of ice in the past; volcanic and thermal activity; movements of the earth's crust; origin of the various types of mountains, valleys, plateaux, plains, lakes, and islands; methods of representing topographical features on maps and diagrams.

(e) Man on the Earth: The division of the world into natural, economic, and political regions; geographical factors controlling the production and exchange of commodities, especially the chief foods and foodstuffs, minerals, and raw materials, and the staple manufactures; distribution of the chief economic plants and animals; factors encouraging or hindering trade.

This section will have special reference to the British Empire and the Pacific area, America and Europe, dealing with the chief geographical and local conditions under which commodities are produced and distributed; with the chief trade-routes and means of transit; with social and political conditions affecting or likely to affect trade with New Zealand; with ports or harbours, coaling-stations; the chief post and telegraph routes; the distribution of population, of minerals, of forests, and of vegetable products; the necessary conditions of development in manufactures, agriculture, and commerce; the distribution of industries.

A candidate in geography will be required to forward to the Department a certificate on the prescribed form that he has carried on satisfactorily a course of practical work in the subject occupying at least thirty hours. Generally speaking, not less than one-half of this total must be spent in the field.

(11) *Agriculture and Dairy Science* (three-hour paper).—(a) Plant Work: General knowledge in considerable detail of the work carried out by plants, with special reference to osmosis, photosynthesis, transpiration, respiration, sap elaboration, translocation, and digestion of reserve foods. Fertilization

and the principles underlying the breeding of new types of plants according to Mendel, De Vries, &c. Methods of seed testing and selection. Development of pure strains by selection. Plant propagation.

(b) Farm Crops: Preparation of soil, sowing, subsequent cultivation, manuring, harvesting, and subsequent treatment of principal farm crops grown in New Zealand, with knowledge of the machinery used in the work. Insect, fungous, bacterial, and weed pests of farm crops and the means used to control them. Economic value of the various farm crops.

(c) Pastures: Economic importance of grasses and clovers found in New Zealand pastures. Choice of seed for particular classes of soil and for various agricultural purposes. Permanent pastures, their management and treatment. Hay and ensilage making.

(d) Orchard Work: Orchard practice, budding, pruning, grafting, spraying, and cultivation.

(e) The Soil: Detailed knowledge of formation of soil. Common rocks of New Zealand which give various types of soil. Sedentary and transported soils and where found. Common indications of good and poor soils. Soil bacteria and their work—*i.e.*, nitrifying, denitrifying, nitrogen-fixing, symbiotic, humus-formation. Limiting factors in soil-fertility—(i) air; (ii) temperature; (iii) water; (iv) harmful conditions; (v) lack of available food constituents. Colloidal matter in soil. Tillage operations—implements used; principles underlying tillage operations. Soil-temperatures. Air in the soil.

(f) Water: Soil-water; sources; kinds of soil-water; movements of soil-water; water-conservation. Principles underlying dry farming. Irrigation. Removal of excess of water from soil. Drainage on large and small scales.

(g) Manures and Fertilizers: Simple (qualitative) chemical analysis of soil and wood ash. Exhaustion of plant-food in soil. Methods of preventing or remedying exhaustion by (i) methods of cultivation and cropping, (ii) soil-improvers, (iii) use of artificial manures. Principles underlying the use of fertilizers. A general knowledge of the various groups of fertilizers—(i) phosphatic, (ii) nitrogenous, (iii) potassic, (iv) lime in all its forms. Laboratory work to cover (i) solubility in distilled water and effect on litmus, (ii) solubility in soil-waters. Physical, chemical, and bacterial effects of liming and green manuring.

(h) Dairy Science: The constituents of milk; causes of variations and of defects in the composition of milk; the physical and chemical properties of milk; the coagulation of milk; the composition of skimmed milk, separated milk, buttermilk, cream, and whey; the uses and value of separated milk, buttermilk, and whey; acidity, and the estimation of acidity; influence of temperature on milk; pasteurizing and sterilizing milk; objections to the use of chemical preservatives; experimental proof that souring of milk is due to bacterial activity; sources of bacterial contamination; injurious bacteria of milk; milk as a medium for conveying disease. Sampling. The examination will include also a knowledge of the construction, manipulation, and principles of manipulation, and principles of working of the apparatus used for testing milk and its products. Methods of raising and separating cream; the ripening of cream; the process of churning; the composition of butter; washing, working, and salting butter. Rennet—how prepared, its action on milk, and the determination of its strength; use of starters; process of Cheddar-cheese making; ripening of cheese, with the changes that occur and the agents at work.

A candidate in Agriculture and Dairy Science will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work in the subject occupying at least sixty hours.

(12) *Physical Science* (three-hour paper).—(a) General Physics: C.G.S. units, velocity, acceleration, force, weight, equilibrium, couples, energy, power, and simple pendulum. Properties of matter—Compressibility, viscosity, and diffusion of gases and liquids; absorption of gases; surface tension, capillarity; rigidity of solids, Hook's law; constitution of matter, atoms, molecules.

(b) Heat: Nature of heat; effects of heat; measurement of temperature; expansion of solids, liquids, and gases, including familiar application; calorimetry; specific heat, latent heat, change of state; refrigeration; liquefaction of air; hygrometry; transformation of energy; mechanical equivalent of heat; conduction, convection; elements of radiation and absorption.

(c) Light: Nature, velocity; photometry; reflection and refraction at plane and spherical surfaces; thin lenses; dispersion and spectra; the principal optical instruments and vision.

(d) Magnetism and Electricity : Production of charge, inverse square law, induction and distribution, electrostatic field, lines of force, potential capacity, condensers, dielectric capacity, electrostatic machines. Magnetic pole, inverse square law, magnetic moment, magnetic field, and lines of force, induction, permeability, terrestrial magnetism. Magnetic force due to currents, galvanometers, Ohm's law, E.M.F., thermal effect of a current; voltaic cells, and electrolysis; interaction of magnets and currents; mutual action of currents, induction coil, thermo-electricity—Simple technical applications illustrating principles, electric waves and radiation.

Questions will be set to test the candidates' knowledge of principles rather than of details. Special importance will be attached to fundamental laws, their simpler applications, and their experimental bases.

A candidate in Physical Science will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work in the subject occupying at least sixty hours.

(13) (a) *Chemistry* (three-hour paper).—Candidates will be expected to show that they have an experimental as well as a theoretical knowledge of the matters set forth in the subjoined syllabus : The three states of matters; indestructibility of matter, physical changes compared with chemical changes. Difference between mechanical mixtures and chemical compounds. Phenomena of chemical action; conditions that promote or check or otherwise modify chemical action. The metric system. Elements and compounds. Modes of chemical action; direct union, displacement, mutual exchange, decomposition. Effects of pressure and temperature on gases; Boyle's and Charles's laws. Estimation of the weight of an element in a given weight of one of its compounds, of the weight of one element required to displace another from a given compound, and of the weight of known volumes of gases. Laws of combination of elements in definite proportions by weight; laws of gaseous combination of elements and compounds; equivalent weights; atoms and molecules, their relative weights; the atomic theory; Avogadro's law; meaning and use of symbols, formulæ, and equations; valency; graphic formulæ; calculations of quantities by volume and by weight; volumetric estimation of acids and alkalies. Production and properties of oxygen, hydrogen, and nitrogen; nitrogen cycle; fixation of nitrogen. Air, its properties, the exact determination of its composition; the constituents of the atmosphere; estimation of the amounts of aqueous vapour and of carbon dioxide. Water, its properties; solution and crystallization; hard and soft water; determination of the composition of water by volume and by weight; production and properties of ozone and of peroxide of hydrogen. The production properties and uses of chlorine, hydrochloric acid, ammonia, oxides of nitrogen, nitric acid. Definition and general properties of oxides, acids, alkalies, and bases; the basicity of acids and the classification of salts. The physical and chemical properties of the various forms of carbon, sulphur, and phosphorus; the production of the two latter on the large scale; the production and properties of the oxides of the three elements just named; carbon cycle; the production and properties of sulphuretted hydrogen, of bisulphide of carbon, of sulphurous and sulphuric acids (manufacture not required), of phosphoretted hydrogen, and of meta-, pyro-, and ortho-phosphoric acids; superphosphate. Experimental determination of the composition of hydrochloric acid, ammonia, carbon dioxide, sulphuretted hydrogen. The halogens, their physical and chemical properties compared; the production of iodine on the large scale; the combinations of the halogens with hydrogen. General properties of metals and non-metals. The chief methods of isolating and the physical and chemical properties and uses of sodium, potassium, ammonium, silver, calcium, zinc, magnesium, copper, mercury, aluminium, tin, lead, manganese chromium and iron; the properties and uses of their more important compounds. The production and properties of the following carbon compounds, with special reference to processes of substitution, oxidation, and reduction; the meaning of constitutional formulæ, and the evidence on which they are constructed, and the characters of homologous series; the homologous paraffins treated as a series; ethylene, acetylene, methyl, and ethyl alcohols, ether, acetaldehyde, acetone, formic acid, acetic acid, and their relations to one another. Petroleum and its products. Elementary knowledge of sugar, starch, cellulose. Oils and fats, soap.

A candidate in Chemistry will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work in the subject occupying at least sixty hours.

Or,

(b) Domestic Science (three-hour paper) : Two of the following sections—
(i) Household chemistry : Study of sugars, starches, fibres, fats and oils,

proteids, extractives, mineral matter or ash, water, volatile products; vitamins; enzymes; separation of the most commonly occurring carbohydrates, proteids, and fats; testing of flour, meal, cereals, sugar, syrup and molasses, edible oils and fats, butter, milk, meats, tea, coffee, cocoa; study of fermentation, yeast, baking-soda, cream of tartar, baking-powder, vinegar, water, soap, caustic and washing soda, borax, bluing, bleaches; the effect of alkalis and organic acids on bright and tarnished metals such as copper, zinc, iron, &c.

(ii) Food Production and Manufacture: Questions based upon the following course—The preparation of the various staple foods from the raw stage to the finished product in marketable form, including the composition, nutritive value, and cost of the available materials—*e.g.*, fruits, vegetables, sugars, meats, edible oils, dairy-products, tea, coffee, chocolate, alcoholic beverages, spices, and condiments; the processes of drying, salting, smoking, canning, and preserving, together with the question of adulteration and substitution; laboratory work, consisting of physical and chemical tests to indicate the composition, purity, and availability of the product; the economic value of the material as ascertained by test.

(iii) Food-preparation: (1) The preparation of food materials based on a knowledge of their composition and the chemical changes effected by heat and moisture; the relative value of cooking processes in retaining nutritive principles in most digestible form, especially the methods of preparation best suited to available forms of a given food material. (2) Study of recipes, to determine how they carry out these principles and economize material, fuel, and labour; the adaptation of established recipes, domestic and foreign, to new-process food materials; the grouping of recipes according to their type forms. (3) Study of the psychological and physiological effect of pleasing flavours; attractiveness and variety in serving; methods of accomplishing these results with a minimum of labour and expense. (4) The cost of food and marketing. (5) Discussion of materials and recipes suitable for school use.

Candidates in Domestic Science will be required to forward to the Department a certificate on the prescribed form that they have carried out satisfactorily a course of practical work in the subject, occupying at least sixty hours.

(14) (a) *Biology* (three-hour paper).—General biological phenomena as illustrated by certain unicellular organisms; cells and tissues of multicellular organisms (to be treated generally); elementary structure and physiology of a vascular plant. General survey of the plant kingdom, as illustrated by algæ, fungi, bryophytes, pteridophytes, and spermatophytes (to be treated very generally); general survey of the animal kingdom to be treated rather as natural history than from structural aspect. The web of life; life-histories of social insects. Symbiosis, parasitism, plant associations; carnivorous plants. General ideas about variation, heredity, evolution, Mendelism, hybridism. Behaviour in unicellular animals. Evolution in relation to the human race.

A candidate in Biology will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work in the subject occupying at least sixty hours.

Or,

(b) *Botany* (three-hour paper).—The structure, physiology, and life history of the following types: *Amœba*, *Sphærella* (*Hæmatococcus*), *Volvox*, *Spirogyra*, *Hormosira*, or any *Fucoid*, *Bacteria*, *Mucor*, *Agaricus*, the yeast plant, *Polytrichum* or any moss, *Pteridium* or any fern, *Selaginella*, *Pinus*. The general morphology, histology, and physiology of Angiosperms, including simple physiological experiments. The characteristics of the following Angiosperm families, with special reference to their New Zealand representatives: *Graminaceæ*, *Liliaceæ*, *Fagaceæ*, *Ranunculaceæ*, *Cruciferae*, *Rosaceæ*, *Leguminosæ*, *Myrtaceæ*, *Scrophulariaceæ*, *Compositæ*. The elements of plant ecology, with appropriate field-work. The elements of plant cytology. Variation, heredity, evolution, and related problems.

A candidate in Botany will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work in the subject occupying at least sixty hours.

Sensation, visual acuity; colour discrimination; auditory acuity; discrimination of pitch; spatial threshold. Attention and perception—range of visual attention; spot pattern tests; form boards; cancellation tests. Learning association and memory tests. Suggestibility. Imagination—ink, blot tests; Meumann, Masselon and Ebbinghaus' completion methods; essay-writing from various suggested themes and cue words. Abstraction. (iv) Vocabulary and information tests. (v) Tests of fatigue, direct and indirect. (vi) Construction and use of "general intelligence" tests. Individual, as the Binet Simon tests and Terman tests. Group, as the Terman, National, Northumberland, Otis tests.

A candidate in Experimental Pedagogy will be required to forward to the Department a certificate on the prescribed form that he has carried out satisfactorily a course of practical work in the subject occupying at least sixty hours.

DIVISION II.

(15) *Latin* (three-hour paper).—(a) Selected portions of the works of one prose and one verse author. Candidates will be expected to show a knowledge of the historical and literary setting of the prescribed books.

(b) Translation of simple unprepared passages, verse and prose, from the language into English; translation of an easy passage from English into the prose of the language; questions on grammar. No candidate shall be deemed to satisfy the requirements in Latin unless he translates, to the satisfaction of the Examiner, at least one of the sight passages from Latin into English.

1932: Livy IX; Virgil, "Aen. VI."

1933: Pliny, "Letters VI"; Virgil, "Aen. XII."

1934: Livy XXIV; Horace, "Odes III, IV."

(16) *French* (three-hour paper).—(a) Unprepared passages for translation from and into French; questions on grammar; composition. No candidate shall be deemed to satisfy the requirements in French unless he translates, to the satisfaction of the examiner, at least one of the sight passages from French into English, and at least one passage from English into French.

(b) Passages from selected works for translation and explanation with questions on the subject-matter of the works selected.

1932: V. Hugo, "Quatre-vingt-treize"; Rostand, "L'Aiglon"; Molière, "Le Misanthrope."

1933: A. Daudet, "Tartarin sur les Alpes"; Racine, "Athalie"; Rostand, "la Princesse Loiraine."

1934: H. Taine, "Voyage aux Pyrénées"; Corneille, "Le Cid"; Molière, "L'Avare."

(17) *Pure Mathematics* (Paper A, Arithmetic and Algebra, three hours; Paper B, Geometry and Trigonometry, three hours).—Every candidate must provide himself with a ruler graduated in inches and tenths and in centimetres and millimetres, a small set-square, a protractor or scale of chords, compasses with pencil-point, and a fine pencil. Tables of logarithms will be supplied.

(a) *Arithmetic*: Contracted and approximate methods of multiplying and dividing numbers, so as to omit all unnecessary figures; use of rough checks, especially with regard to the position of the decimal point; use of such expressions as 1.732×10^4 for 17320, and 1.732×10^{-3} for 0.001732. Meaning of a common logarithm; use of logarithmic tables of four or five figures. Calculation of numerical values from formulæ. Working of problems in practice, interest, &c., by decimals; use of squared paper, and application of graphical methods to arithmetical problems. A knowledge of the arithmetic and mensuration included in the programme of the Training College Entrance Examination will be assumed.

(b) *Algebra*: Definitions and explanations of algebraical signs and terms; addition, subtraction, multiplication, and division of algebraical quantities, including easy fractions and easy surds (the candidate will not be expected to show skill in the manipulation of complicated formulæ, but he may be required to ascertain accurately the numerical value of any quantity or expression given to him); easy equations of a degree not higher than the second, and questions producing such equations; easy arithmetical and geometrical series; graphs of simple algebraic functions within the limits of the foregoing work, and graphical methods of solving equations.

(c) *Geometry*: Practical and theoretical geometry as in the Training College Entrance Examination, together with the following:—

(PRACTICAL.)

- To draw a normal to a plane from an external point.
- Projections of a point on three planes at right angles.
- Determination of a point by means of its co-ordinates (x, y, z), referred to three rectangular axes and by means of its polar co-ordinates.
- Projection of a straight line on a plane making a given angle with it.
- Projection of a plane figure on a plane making a given angle with it.
- Development of the right prism, and of the right pyramid.
- Determination of the surface, the base being a regular polygon of the right prism and right pyramid.
- Volume of the prism and pyramid.
- The generation of the right circular cylinder, right circular cone, and sphere by revolution.

Development of the right circular cylinder, and right circular cone ; the surface of each.

Volume of the cylinder, cone, and sphere.

(THEORETICAL.)

If a straight line is drawn parallel to one side of a triangle, the other sides are divided proportionally ; and the converse.

If two triangles are equiangular, their corresponding sides are proportional ; and the converse.

If two triangles have one angle of the one equal to one angle of the other, and the sides about their equal angles proportional, the triangles are similar.

The internal bisector of an angle of a triangle divides the opposite side internally in the ratio of the sides containing the angle, and likewise the external bisector externally.

The ratio of the areas of similar triangles is equal to the ratio of the squares on corresponding sides.

If two similar polygons have their corresponding sides parallel, the lines joining corresponding vertices are concurrent.

The ratio of areas of similar polygons is equal to the ratio of the squares on corresponding sides.

In equal circles (or in the same circle) the ratio of any two angles at the centre or on any two sectors is equal to the ratio of the arcs on which they stand. The rectangle contained by the diagonals of a cyclic quadrilateral is equal to the sum of the rectangles contained by the two pairs of opposite sides.

(d) *Trigonometry* : Degrees and radians ; use of protractor or scale of chords ; trigonometrical functions and their fundamental relations ; determinations of their value by graphical methods and setting-out of angles when the value of the sine, cosine, or tangent is given. Approximate solution of right-angled triangles and oblique triangles by drawing to scale ; tracing of trigonometrical functions through the four quadrants ; arithmetical values of the trigonometrical functions of 30° , 45° , 60° , 75° , 90° , &c. Formulæ for finding the sine, cosine, and tangent of the sum or difference of two angles (excluding angles greater than two right angles), and easy derived formulæ ; the sine rule in triangles, or $\sin A/\sin B = a/b$, and other simple properties of triangles ; the area of a triangle. Use of natural and logarithmic tables of sines, cosines, and tangents of four or five figures. Solution of triangles ; heights and distances.

Skill in the transformation of trigonometrical expressions or in the manipulation of formulæ will not be required, except in so far as it is implied in the above syllabus.

(18) (a) *Psychology* (three-hour paper).—Scope and methods of psychology ; the nervous system ; reactions at different levels ; native and acquired traits ; sensation ; attention ; intelligence ; habit and intelligence in animals ; learning and habit formation in general ; memory ; association and mental imagery ; perception ; reasoning ; imagination ; work ; fatigue ; sleep ; instincts and emotions ; the feelings ; dispositions ; temper ; temperament and moods ; the development of sentiments, the development of the will ; the organization of character ; personality.

Or,

(b) *Experimental Pedagogy* (three-hour paper).—A knowledge of the chief lines of experimental investigation of educational processes. The practical work in Experimental Pedagogy shall be as follows : (i) Simple statistical methods applied to education—*e.g.*, measure of central tendency (mean, median, mode), degrees of variability (mean and standard deviations, probable error), correlation formulæ, methods of graphical representation. (ii) Physical measurements—*e.g.*, measurements of head, stature, weight, vital capacity, grip, and the calculation of indices ; and the possible relation of these to normal mental and physical development. (iii) Measurement of specific capacities in school-children—such experiments as the following :

(19) *History* (three-hour paper).—(a) British History from the beginning of the Norman period to the present day with special reference (i) to the following phases in national development : The establishment and decay of the manorial system ; progress in social life and education during the later Middle Ages ; the industrial, political, and social developments during the Tudor and Stuart periods and throughout the 18th and 19th centuries ; the establishment of the British Empire and its development, especially since 1800 ; and (ii) to the relations of Great Britain with other countries at the following points : The Renaissance and Reformation periods ; the colonization period of the 17th and 18th centuries ; the French Revolution and the Napoleonic era ; nationalism and internationalism in the 19th and early 20th centuries ; the development of international rivalries just prior to the

Great War; the disarmament movements of the last decade; problems of the Pacific.

(b) *New Zealand History*: A fairly detailed study of Maori history, life, and customs, and of the early history of New Zealand and of each province; the chief features in the development of New Zealand and Australia since 1850.

(c) *Civics*: The leading features of civic and parliamentary government in New Zealand.

(d) An historical notebook (or notebooks) indicating the personal work of the candidate in the collection and presentation of material for lessons on ten topics chosen from different portions of the above syllabus will be required from each candidate. These notebooks are to be forwarded direct to the Department on or before the 1st August.

(e) *Original Investigation*: Each candidate shall submit a thesis embodying the results of an original investigation that he has made into the history of some locality in New Zealand.

(20) *School Handwork*.—(a) *Written Test* (three-hour paper): (i) Principles and methods of handwork for kindergarten, infant, and primary-school classes, including paper-folding, paper-tearing, &c.; elementary cane and raffia work; stencilling and surface decoration of various kinds commonly used in the classroom, modelling in plasticine, clay, and other materials. The use of handwork in illustration of history, geography, arithmetic, and other subjects of the public-schools syllabus.

(ii) Handwork for post-primary classes up to Form III and simple crafts suitable for such classes. The materials, tools, processes, and design used in or suitable for one of the following crafts: Basketry; linoleum cutting and printing; leather-work; weaving; matmaking; embroidery and advanced needlework; modelling in clay or plasticine.

Note.—Papers in Part ii will be set in accordance with the crafts chosen by candidates for the practical test, and each candidate will be examined in relation to his chosen craft.

(b) *Practical Tests* (four-hour paper): (i) (two hours): Simple exercises in handwork suitable for kindergarten, infants, or primary-school classes, including cane and raffia work, modelling in clay or other plastic material, &c.

(ii) (two hours): An exercise in one craft chosen by the candidate from the list in Part ii of Paper (a).

Candidates will be expected to show skill in their chosen craft sufficient to enable them to teach it efficiently to pupils in the higher classes.

(21) *Woodwork and Metalwork*.—(a) *Written Paper* (three hours) Materials, tools, processes, and drawing required for carrying out work specified for the practical examination. Half the time shall be devoted to sketches and drawing with instruments, including freehand sketches sufficiently accurate and detailed to serve as guides to construction, and geometrical drawing including orthogonal, oblique, and isometric projections to a suitable scale of simple objects or tools within the range of the prescription for practical work.

(b) *Practical Examination* (four hours): (i) *Woodwork*: The adjustment, sharpening, and setting of edge tools. The following woodwork joints and their application in the construction of simple objects: Housed, halved, bridled, doweled, mortise and tenon, dovetail halving and box dovetail. The reduction of suitable pieces of wood to simple straight or curved forms by means of the ordinary hand-tools of the carpenter and joiner, including simple rebating, chamfering, ploughing, and inlaying. Fastening of wood by nails, screws, and glue; fixing in position of hinges, catches, and locks or other fasteners.

(ii) *Metalwork*: Sheet-metal and wire work, involving such operation as can be performed with the use of bench, vice, stakes, small anvil, small drill (up to $\frac{3}{8}$ in. holes), and hand-tools, including cutting, beating, and bending sheet metal up to $\frac{1}{16}$ in. in thickness, twisting and bending wires up to $\frac{1}{8}$ in. diameter; soldering with hard and soft solder, working out designs in beaten, bent, and twisted sheet metal and wire; cutting and screwing metal wires and rods up to $\frac{3}{8}$ in. diameter; filing, cutting, and bending sheet metal up to $\frac{1}{8}$ in. in thickness.

Candidates will be expected to be able to construct models of simple developable surfaces, and also to produce from ductile metal sheet by beating articles incorporating simple non-developable surfaces. Making, hardening, and tempering of small tools such as a small dotting punch, a chisel, a flat drill. A knowledge of the elements of Whitworth threads $\frac{1}{16}$ in. to $\frac{1}{2}$ in. and of B.A. threads Nos. 0-8 will be expected.

Decoration: The more elementary decoration of articles in wood by means of painting, inlaying, and carving or incising, and of articles in metal by simple repoussé, pierced, or filigree work. The combination of wood and metal in the construction and decoration of simple objects for use or ornament.

IN pursuance of the powers and authorities conferred upon him by sections nine and two hundred and twenty-six of the Harbours Act, 1923, and of section five of the Fisheries Act, 1908, and of all other powers and authorities enabling him in that behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations as to foreshores vested in or under the control of His Majesty, and doth hereby order and declare that they shall come into and be in force on the date of their publication in the *Gazette*.

REGULATIONS.

1. No person shall promote, conduct, or engage in any motor-vehicle speed tests or races in any portion of foreshore unless such person has first obtained the permission in writing of the Minister so to do.
2. The granting of such permission shall be subject to such conditions and restrictions as the Minister may impose.
3. (1) The Minister may—
 - (a) Prohibit, upon any day on which any speed tests or races hereinbefore referred to are held, the use of such foreshore by pedestrians or horsemen, or by any vehicles other than those engaged in such tests or races, and those required for the use of officials concerned therewith; and also the driving or bringing of stock upon such foreshore.
 - (b) Prohibit fishing or the taking of fish from such foreshore, or the conveyance on to such foreshore of any device for taking fish, on the day or days upon which such tests or races are held and for any period not exceeding one week prior to such day or days.
 - (c) From time to time appoint any officers required to carry out or assist in the administration of these regulations.
- (2) Any person doing anything prohibited by the Minister from being done pursuant to this regulation shall be deemed to have committed a breach of these regulations.
4. Any person committing a breach of any of these regulations shall be liable to a fine of £20.

42. It shall be unlawful to use a set-net for taking fish in any portion of the Wanganui River, or to use a net of any description whatever for taking fish in that portion of the said river above a point three miles up the river from the Aramoho Railway Bridge. Such point shall be marked by a white post on each bank of the said river, having the words "Netting limit" painted thereon: Provided that this regulation shall not apply to nets allowed by any regulation for the time being in force to be used for taking whitebait in the said river.

Now, therefore, in pursuance and exercise of the powers and authorities conferred upon me by section 23 of the Shipping and Seamen Act, 1908, and of all other powers and authorities enabling me in that behalf, I do hereby make the following rules for the purpose aforesaid, and do hereby order that these rules shall come into force on the 1st day of January, 1932.

RULES.

1. MEMBERS of the R.N.V.R. may, on the recommendation of the Officer commanding the Division, be examined for a Certificate of Efficiency in Navigation. This certificate, which will be issued by the Marine Department, is purely honorary, and will not be available for use in any capacity whatever on board ship.

2. The name of a candidate who desires to be examined should be submitted to the Principal Examiner by the Officer commanding the Division, together with his recommendation.

3. Candidates must comply with the rules for the conduct of examination of masters and mates, and must fill in an application form (Exn. 2) and pay a fee of £1 at a Mercantile Marine Office. If they should be successful in passing the examination, a fee of 2s. 6d. will be charged for the certificate. Candidates will not be examined in sight test.

4. Candidates will be examined in the written part of the syllabus for a Certificate of Competency as Master of a Home-trade Ship defined by Rules Nos. 86-89 inclusive of the rules for examination of Masters and Mates for Certificates of Competency, and in the use and adjustment of the sextant.

THE STOCK EXCHANGE CORPORATION OF NEW ZEALAND, LIMITED.

STOCK EXCHANGE RULES.

(Pursuant to Article 147A of the Articles of Association of the company and section 9 of the Sharebrokers Act, 1908.)

1. THE Stock Exchange Corporation of New Zealand, Limited (hereinafter called "the Exchange"), shall consist of members engaged in the purchase and sale of shares, stocks, debentures, debenture stocks, bonds, obligations, securities, mortgages, and monetary transactions.

Objects.

2. The objects and purposes of the Exchange are to provide, regulate, and maintain a suitable building, room, or rooms in the City of Auckland, and such other place or places as the Committee shall determine, for the promotion and facilitation of dealings in stocks, shares, and monetary transactions; to establish just and equitable principles in the transaction of business, to adjust controversies between its members, and to maintain uniformity in its rules and usages.

Members.

3. Any person who shall hold a license under the Sharebrokers Act, 1908, and shall hold not less than five preference shares in the capital of the Stock Exchange Corporation of New Zealand, Limited, shall be entitled to be a member of the Exchange upon the terms and conditions hereinafter appearing.

Management.

4. (a) The management of the Exchange shall be vested in a Committee consisting of the chairman and directors for the time being of the Stock Exchange Corporation of New Zealand, Limited, and such Committee shall have (subject to these rules) the direction and control of the affairs of the Exchange.

(b) Meetings of the Committee shall be held at such place and at such times, and such notice thereof shall be given as the Committee shall from time to time determine. Unless the Committee otherwise determines, the Secretary shall give to the members of the Committee notice of each meeting not later than the day before the date on which such meeting is to be held.

(c) A member of the Committee shall not at any meeting take any part in any proceedings relating to any complaint concerning such member, or otherwise having reference to the conduct of such member, or relating to any other matter in which such member has a special interest, and such member shall not be entitled to vote at any subsequent meeting of members dealing with any such subject or matter.

(d) A member of the Committee shall not take part in any of its meetings pending the investigation of a charge affecting himself.

(e) The surviving or continuing members on the Committee, notwithstanding any vacancy in their number, may act until the vacancy be filled up.

(f) At meetings of the Committee all questions shall be decided by a majority of the members present.

(g) The quorum for meetings of the Committee shall be four (4).

(h) The Secretary and Treasurer of the Exchange shall be the Secretary for the time being of the Stock Exchange Corporation of New Zealand, Limited. The Secretary shall have the custody of all books and papers. He shall present at each annual general meeting a statement of the finances of the Exchange to the end of the previous year, duly audited by the Auditor for the Stock Exchange Corporation of New Zealand, Limited. All profits shall be the absolute property of the Stock Exchange Corporation of New Zealand, Limited, which shall bear any losses.

(i) In the absence of the Secretary from any meeting, or in case of his suspension, the Chairman shall carry out his duties, or may appoint another member to do so.

(j) The Chairman, who shall be the Chairman of Directors for the time being of the Stock Exchange Corporation of New Zealand, Limited, shall preside at all meetings of the

Exchange and of the Committee, but in the event of his absence the members present shall elect a Chairman for that occasion.

(k) The Chairman of any meeting shall have entire control thereof, and shall regulate the order and manner in which the business shall be conducted. The decision of the Chairman shall be final in all cases submitted to him.

(l) In all cases, at any meeting when on a division the votes are equal, the Chairman shall have a second or casting vote.

(m) In the event of any member or members obstructing the business of the meeting or being guilty of any breach of etiquette, of which the Chairman shall be the sole judge, the Chairman shall have power to inflict such fine, not exceeding £5, as he may deem advisable.

(n) The financial year of the Exchange shall close on the 31st day of March. A general meeting of members shall be held annually in the month of May, at which the business shall be to receive from the Treasurer a balance-sheet showing the financial position of the Exchange and also generally to conduct any business provided for in these rules.

(o) At any annual general meeting, after all business herein provided for shall have been disposed of, it shall be competent for any member to bring under the notice of the meeting any business or matter within the objects or purposes of the Exchange, and to give notice of any proposition to be considered at a future meeting.

(p) A special general meeting may be called by the Committee at any time.

(q) No other business shall be transacted at a special general meeting except that stated in the notice convening the meeting, and no resolution shall be passed, or other business transacted, which is not included within the objects and purposes for which the meeting is convened. No amendment shall be allowed upon any resolution contained in the notice convening any meeting not directly pertinent thereto.

(r) Any general meeting shall have power *inter se* to adjourn from time to time as may be found necessary. Whenever an adjournment to a future day has been decided on, notice thereof shall be given in such manner as may be determined by the Chairman of the meeting. No business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting so adjourned.

(s) Every member shall have one vote, and all questions shall be decided by a majority of the members present and voting, except in cases otherwise provided for in these rules. Voting by proxy shall not be permitted.

(t) The quorum for general and special meetings shall be not less than one-third of the total members of the Exchange for the time being entitled to vote.

Funds.

5. (a) The Committee shall have full control over the funds of the Exchange, and shall pay therefrom all current expenses and outgoings, and any other payments for which they have the authority of the members. All moneys received shall be paid into a bank account, and all accounts, salaries, &c., shall be paid by cheques drawn on such account.

(b) The Committee shall invest the funds as they may in their absolute discretion think advisable, and shall have power to sell and vary investments.

(c) Cheques drawn on or against any funds of the Exchange shall bear the signatures of the Secretary and of the Chairman.

Entrance Fee.

6. An entrance fee of such sum as the Exchange may from time to time determine shall be paid by candidates for membership at the time of application for admission. In the event of a candidate being rejected, his entrance fee shall be returned to him.

Subscription.

7. An annual subscription of such sum as the Exchange may from time to time determine shall be made payable at such time and in such manner as the Committee may consider necessary. New members shall pay on election the subscription which shall have been levied for the current year. Any member not paying his subscription within two calendar months after the same shall have been levied shall be charged an additional sum equal to the amount of the subscription levied, and if such additional sum together with the subscription is not paid within four calendar months from the time when such subscription was levied, he shall be deemed to be suspended from the privileges of his membership, and shall continue so suspended until such time as he has paid the subscription and the additional sum charged through non-payment of the subscription during the first two months. Failing payment within twelve months of the date on which the subscription first became payable of such subscription and

any additional sum payable as aforesaid, he shall immediately, upon the expiration of such twelve months, *ipso facto*, cease to be a member, and his seat shall be forfeited to and become the property of the Exchange.

Election.

8. Every candidate for admission to membership must be proposed by a member and seconded by another member, and such nomination shall then be submitted to the Committee, whose decision thereon shall be final. No rejected candidate shall be again proposed for election within the space of one year after his rejection. Every member shall sign the rules, and no member shall be entitled to the privileges of membership until he has done so.

9. The rights and privileges of every member shall be personal to himself and shall not be transferable by operation of law or by his own act or otherwise howsoever, nor shall members who resign or cease to be members from any cause whatever or the executors or administrators of any deceased member have any claim whatsoever on the assets of the Exchange.

Defaulters.

10. (a) The Committee shall suspend for such period as it shall think fit and may also fine or recommend for expulsion any member who shall fail to pay when due any debt incurred by him to another member. Should the Committee decide to recommend the member's expulsion, they shall report accordingly to the members at a special general meeting called for that purpose. It shall be competent for the said special general meeting to confirm the Committee's recommendation and expel the member so brought before them, or deal with him by fine or suspension from membership. A member who becomes insolvent or assigns his estate for the benefit of, or compounds with his creditors, shall, *ipso facto*, cease to be a member, and shall forfeit to the Exchange all interest in his membership, and in the funds and property of the Exchange, notwithstanding that he may not be at the same time a defaulter on the Exchange; but such member may be reinstated by the Committee without payment of fee after he has obtained his discharge from his insolvency, or a release from his creditors.

(b) The Committee shall have power to order that all open transactions, including time bargains, between any member unable to meet his engagements and other members, shall be closed within a time to be named by the Committee. Such transactions shall be closed accordingly, by the Chairman buying or selling in the market on account of the member in default, such stocks or shares as he may have contracted to sell or purchase. The Chairman shall charge current rate of brokerage to the defaulter, and such brokerage shall be the property of the Chairman. Members shall, without delay, render full statements of account to the Committee.

(c) In case any member shall make default in payment of any amount payable to any other member, the last mentioned member shall give notice in writing of such default to the Chairman, within twenty-four hours after such default.

(d) The Committee shall have power to investigate the accounts of members with a member in default, and to reject or require the correction of any items which they may deem unsatisfactory.

(e) Members, creditors of a member in default, shall have a preferential claim on all surpluses in the hands of other members, resulting on the closing of transactions open at the time of default, and also on all moneys which may become payable to a member in default out of funds in the hands of the Committee from the estate of another member in default. All surpluses in the hands of members resulting on the closing of open transactions with a member in default shall be paid to the Committee.

(f) The Committee shall distribute as soon as possible amongst members, creditors of the member in default the surpluses received from other members on his account, and all moneys due to him out of funds in the hands of the Committee from the estate of another member in default.

Commission.

11. The rates of brokerage shall be those fixed or adopted from time to time by the London Stock Exchange.

Official Meetings.

12. (a) The official meetings of the Exchange shall be the meetings of members held at such place and times as the Committee shall appoint, at which the business shall be to make prices, effect sales, and receive and record quotations of sales; also to do any general business in accordance with these rules. The quorum for an official meeting shall be not less than one-sixth of the total members of the Exchange for the time being entitled to vote.

(b) A member shall not leave an official meeting without the permission of the Chairman under penalty of a fine of £5, which shall be paid within seven days.

Quotations.

13. (a) At the official meetings the prices made shall be binding on members making them to the extent of the minimum quotation. No sale shall be made while the record of business done is being called over, or during any time of suspense ordered by the Chairman.

(b) The highest declared buyers shall have priority over all other members in purchasing the stock in question at the price named. But having made a purchase, he must, to retain his priority, immediately declare himself as still a buyer.

(c) The lowest declared seller shall have priority over all other members in supplying the stock in question at the price named. But having made a sale, he must, to maintain his priority, immediately declare himself as still a seller.

(d) After any stock has been called and passed, business in that particular stock can only be re-opened at the buying or selling quotation.

(e) All sales of stocks and shares made at official meetings shall be quoted, except sales not amounting to a quotation. Due date must accompany quotation of debentures. Members shall not publish in the newspapers quotations of shares. Time bargains shall not be made at an official meeting, except in the following manner—viz., at the conclusion of the ordinary business. Any member may name any stock or shares in which he wishes to make a time quotation, and such stock or shares shall then be called for time transactions only. Sales effected by members as intermediate brokers shall not be quoted.

(f) If any quotation of sale be challenged, the Chairman of the day shall immediately accompany the member whose quotation is doubted to his office, and there satisfy himself by examination of the books or papers of such member as to the *bona fides* of the quotation; and shall report the result either to the Committee in the first instance or direct to the members in official meeting assembled, as to him shall seem fit. Any member refusing to the Chairman an inspection of his books shall be treated by the Committee as guilty of making a false quotation. An offender shall be considered as guilty of conduct unworthy of a member, and be dealt with accordingly.

Official List.

14. (a) The list of quotations of prices and of purchases and sales effected and reported at the daily meetings of the Exchange shall be the official list of the Exchange. The Committee may, if it so thinks fit, issue a monthly list. No member shall issue a private list or general report.

(b) Admission of companies to quotation on the official list shall be on such terms and conditions as the Committee shall from time to time determine. The Exchange shall have power to suspend for any period, or withdraw altogether, the name of any company or association from the official list.

Register of Sales.

15. All sales made at official meetings shall be recorded in a register kept for that purpose, which record shall be called over before the close of such meeting, and members shall be bound thereby. Stamped contract notes for all transactions in mining shares shall be passed between members, and in the event of a dispute, unless the contract note shall have been returned within a reasonable time, it shall be *prima facie* evidence of a sale having been effected, and at the price stated therein.

Inviolability of Contract.

16. In contracts between members for the sale and purchase of shares and stocks they shall be held to be principals to each other unless a written arrangement to the contrary be made between buying and selling broker at the time of the contract being made.

Delivery and Settlement.

17. (a) Three clear days shall be allowed for delivery of documents by the seller, and failing delivery thereof during that period, the buyer may after 1 p.m. on the third day give twenty-four hours' written notice to the seller to deliver such documents, and failing such delivery the buyer may either cancel the purchase or buy at the risk of the seller through the Chairman of the Stock Exchange. Any deficiency or surpluses shall be adjusted between the parties by the Chairman. The defaulter shall settle the amount of any resulting deficiency within twenty-four hours. If, however, at the time of the sale the seller shall inform the buyer that the transfer has to come from a distance requiring a longer period than three days to deliver, it shall be at the option of the purchaser to refuse to complete the transaction.

(b) Purchasers shall not be required to take delivery of any pay for documents until the day following the sale. All documents must be delivered before 11 o'clock on Saturdays and 1 o'clock on other days, otherwise it shall not be incumbent on purchasers to pay for same until the following day.

(c) Sellers shall have the right to require the purchase-money to be paid in cash or by marked cheque at the time and place of delivery of documents. In case of failure of payment by the buyer, the vendor may, within one day of default of settlement or on any future day, either cancel the transaction or sell at the buyer's risk through the Chairman of the Exchange the securities involved, and the defaulting member shall forthwith pay to the vendor any difference between the original purchase-money and the net proceeds of the securities resold.

(d) If delivery of documents has not been made within the time specified above, and the buyer has not cancelled the purchase or bought at the risk of the seller as therein provided and the seller shall tender delivery of documents after the expiration of six weeks from the date of the sale, the buyer shall not be bound or compellable to accept delivery of such documents unless some special agreement in writing has been entered into between the buyer and the seller in respect of such delivery.

(e) When a buyer shall claim delivery of documents after the expiration of six weeks from the date of purchase, and the seller shall not have cancelled the sale or sold at the buyer's risk, it shall not be incumbent upon the seller to deliver unless some special agreement in writing has been previously made between the buyer and the seller in respect of such delay.

(f) The refusal of the Board of Directors of any company to register a transfer shall not invalidate a sale.

(g) Sellers shall deliver separate transfers and scrip representing a sufficient number of shares sold in each sale if required to do so. Buyers requiring scrip must have transfers delivered with scrip attached, or a memorandum equivalent to such scrip certified to by the company. A seller of shares in London companies, having a colonial register, shall deliver scrip on the colonial register, unless otherwise arranged at time of sale. The selling broker shall be responsible for a period of seven clear days from date of delivery for the validity of all documents delivered, and for the shares being free from all liability due or payable at the time of sale.

(h) Sellers shall have the right to demand from the buyer, prior to delivery, a name for insertion in the transfer of investment shares. Failing the buyer complying with such demand within three clear days from date of sale, the seller may insert the name of the buying broker. A member shall not be bound to accept delivery of a transfer signed by a transferee and his signature cancelled, or filled in with a transferee's name and the name cancelled.

(i) Buyers shall have the option of refusing all transfers or scrip signed under Power of Attorney or per procuracy, unless the signature thereto be certified as correct by the Secretary of the Company, or the documents be accompanied by a valid power of attorney.

(j) No member shall print or affix his name stamp on any transfer or scrip delivered to another broker.

(k) In all forward contracts for shares or stocks, except where it is otherwise specifically agreed in writing between the parties at the time of sale, there shall be implied the following conditions: The seller may at any time and from time to time whenever the market price of the shares or stock is less than the amount for the time being owing under the contract, and the buyer may at any time and from time to time whenever the market price of the shares or stock exceeds the amount for the time being owing under the contract, by application or notice to the other in writing, require that the contract be kept to the market price by payment to the Secretary of the Exchange of the difference between the contract price and the market price. Notification of such application or notice shall be forthwith lodged with the Secretary. Any written notice may be served or application made by delivering the same to the other party personally, or by leaving the same at his registered address, and shall be deemed to be duly served or made when so delivered or left as aforesaid. No such application shall be made, or notice served, on Saturdays or Exchange holidays, or after 1 o'clock in the afternoon of any week-day. Whenever any such application shall have been made, or any such notice shall have been duly served as aforesaid, the person to whom such application shall have been made, or upon whom such notice shall have been served, shall, before 2.30 p.m. on the same day, pay to the Secretary of the Exchange a sum equal to the difference between the market price of the shares or stock at the time of such application or service, and the amount then owing under the contract; such payments to be made in cash or marked cheque if so demanded. The

amount so paid in shall be held by the Secretary upon and subject to the following trusts and conditions, viz. :-

- (1) If the amount has been paid by the seller, and before the date fixed for completion of the contract the market price of the shares or stock falls to the contract price, then such amount shall be repaid to the seller if demanded :
- (2) If the amount has been paid by the buyer, and before the date fixed for completion the market price of the shares or stock rises to the contract price, then such amount shall be repaid to the buyer if demanded :
- (3) The said amount shall in any case be repaid to the party paying same, at the written request of the other party :
- (4) The said amount shall be repaid to the party paying same on the Secretary being satisfied that the contract has been completed :
- (5) If the party who has paid such amount shall fail to complete the contract, then the said amount shall be applied in the first place in paying to the other party the amount which the defaulting party is liable to pay to him, as hereinafter provided, and the balance, if any, shall be applied firstly in paying the brokerage payable to the Chairman, as hereinafter mentioned, and secondly, towards the payment of any fine or fines inflicted upon the defaulter :

Provided always that the seller may, in lieu of paying to the Secretary of the Exchange the difference between the market price and the amount owing under the contract, deposit the shares or stock in manner hereinafter mentioned. When any shares or stock are deposited under the provisions of this Rule, such shares or stock shall be deposited with the Secretary of the Stock Exchange, or with such other person or persons as may be mutually agreed upon by the parties to be held by the Secretary, or other person or persons, pending the due completion of the contract. On payment of the amount payable under the contract, the shares or stock shall be delivered to the buyer, but if the buyer shall made default in such payment, such shares or stock shall be returned to the seller.

In this rule, unless otherwise expressed, the "market price" shall mean the market price of the shares or stock at the time when application is made, or the notice is served as aforesaid, as the case may be. All disputes as to the market price shall be decided by reference to the Chairman of the Exchange, or, in his absence, to any member of the Committee who may be available and mutually agreed upon, whose decision shall be final, conclusive, and binding on all parties.

If default shall be made by the buyer in complying in manner aforesaid with any such application or notice as aforesaid, or in completing the purchase at the time fixed by the contract the seller may in either or any such case forthwith at his option either cancel the contract or sell out the shares or stock through the Chairman, and the purchaser shall forthwith pay to the seller the difference between the contract price and the net proceeds from the sale. If default shall be made by the seller in complying with any such application or notice as aforesaid, or in completing the purchase at the time fixed by the contract, the buyer may, in either or any such case, forthwith at his option, either cancel the contract or buy at the risk of the seller through the Chairman, and the seller shall forthwith pay to the buyer the difference between the contract price and the gross amount paid by the buyer. The Chairman shall charge the usual rates of brokerage on all such sales as aforesaid the amount in each case to be paid by the defaulting party.

Dividends.

18. (a) Transactions in shares shall be with dividend, until the dividend is payable. When transfers are delivered subsequent to the declaration of a dividend, but prior to the closing of the books of the company and in sufficient time for the registration of the shares, the seller shall not be responsible for the dividend, and the buyer's claim shall be only upon the registered holder; but when no reasonable time is afforded to the buyer to register the shares in his own name, then the seller shall be responsible for the dividend.

(b) Dividends payable between the date of sale and the maturity of time-bargains shall accrue to the buyer, and shall be accounted for at the time of settlement of the bargain.

(c) Interest on debentures shall be charged to the date of sale in addition to the price.

Calls.

19. All calls made prior to time of sale shall be paid by the seller before delivery. Calls made between the date of sale and maturity of time-bargains shall be paid by the buyer to the seller at the time of settlement of bargain.

Time-bargains.

20. (a) Unless otherwise agreed, neither party to a time-bargain shall be entitled to call upon the other party to complete until the day fixed for completion.

(b) Time-bargains, the day for completion of which shall fall on a Sunday or Exchange holiday, shall not be completed until the business day next following.

New Shares.

21. In the event of new shares being created and offered to the shareholders in any company during the currency of a time-bargain, or pending delivery of shares in time for the buyer to complete transfer to enable him to secure such new shares himself, the buyer, if desirous of receiving his proportion of such new shares, shall request the seller in writing accompanied by the necessary funds to secure them, and the seller, on receipt of such request, shall secure them, but the seller may elect to deliver such documents as will enable the buyer to secure the new shares.

When a transaction is in shares on a London Register, the responsibility of the seller shall cease if he shall have taken every practicable course to secure the new shares, and further, the seller shall be relieved of all responsibility if the circumstances place him in no better position than the buyer to secure the new shares, in which case the seller may, on receipt of a written request from the buyer to protect his rights, notify the buyer in writing of such circumstances, and the buyer, on receipt of such notification, shall protect his own interests.

Non-members—Failure to meet Engagements.

22. (a) Non-members shall pay for all stock or shares purchased on their account before two o'clock on the day following the purchase, unless an agreement be made in writing to the contrary.

(b) Should a purchaser, not a member, fail to pay the amount due on his purchase in accordance with the preceding rules either the seller or his broker, or the purchaser's broker, shall be at liberty, at any time thereafter, at his or their option either to sue such purchaser for breach of contract, or to resell the securities in any manner, and upon such terms and conditions as he or they may think proper, and to sue for the difference and all loss and expenses consequent upon such resale, whether the same shall be made immediately on such failure to pay as aforesaid, or at any time thereafter; and all damages which the seller or his broker or the purchaser's broker may sustain thereby, shall be recoverable by him, or them, from the purchasers as and for liquidated damages, and it shall not be necessary to give notice of any such resale.

(c) In the event of any person not a member failing to meet any engagement with a member of the Exchange, the member may apply to the Committee to have such person posted as a defaulter. The Committee shall inquire into the case, and if satisfied that such default has been made, shall post the said person and announce to the members that he is in default.

(d) A member shall not transact business for a non-member who has been announced to the members as a defaulter, unless such person shall have made an arrangement with his creditor or creditors satisfactory to the Committee.

Disputes.

23. (a) In disputes between members, with reference to stock and share transactions, brought under the consideration of the Committee, the decision of the Committee shall be final and binding and shall be carried out forthwith by the member or members concerned.

(b) Unless permission of the Committee has first been obtained, members shall not appeal to any Court of Law or Equity in any dispute that may arise between them in transactions under these Rules, and if such permission is not granted they shall accept the Committee as the sole and final tribunal and arbiter therein.

(c) It shall not be incumbent upon the Committee to entertain any complaint submitted to them by any one not a member of the Exchange against a member of it, unless such member shall have been employed by the complainant in the capacity of broker; and in that or any other case in which a non-member desires the intervention of the Committee, he shall previously to the case being heard, pay not less than five guineas, or such other sum as the Committee may determine, to the Secretary, and shall undertake in writing to abide by and forthwith to carry out the decision of the Committee in the same manner as if he were a member of the Exchange; the Committee to have the power to repay the whole or part of the five guineas or such other sum to the complainant.

Investigations.

24. (a) Members and their clerks when required so to do by the Committee shall attend any meeting of the Committee, and then and there shall give such information as may be in their possession relative to any matter under investigation.

(b) The Committee shall have full and absolute power, in the event of a complaint being made, which in their opinion justified such procedure, to call upon any member to produce for their inspection all books, letters, telegrams, or copies thereof, and other documents in his possession relating thereto, and he shall, without delay, produce them for inspection accordingly.

Penalties.

25. (a) The Committee shall take cognizance of all violations of these rules, whether in letter or spirit. Any member found by them to be guilty of such violation, or who may fail to comply with any decision or ruling of the Exchange or of the Committee, or who, in the opinion of the Committee is or has been guilty of conduct unworthy of a member, shall be liable to be fined or suspended or fined and suspended from membership by resolution of the Committee; or should the matter be of such moment as in their opinion to demand expulsion, the Committee shall report accordingly to the members at a special general meeting called for that purpose. It shall be competent for the said special general meeting to confirm the Committee's recommendation and expel the offending member, or to deal with him by fine or suspension.

(b) The fines mentioned herein shall not, except in cases where another amount is fixed, be less than £25 or more than £100, and in case of a continuous offence shall be not less than £5 or more than £10, for each day during which such offence continues.

(c) Any member of the Exchange who shall fail to observe or be bound by the terms of any decision or ruling of the Committee or of the Exchange, or the spirit or intention thereof relative to the conduct by the members of the Exchange of their business as such members, or to their dealings with one another as such members, or relative to other matters arising out of the objects or purposes of the Exchange, shall be deemed guilty of conduct unworthy of a member, and be dealt with in manner provided by Rule No. 25 (a).

(d) If a fine imposed on any member at a special general meeting of members be unpaid at the end of one clear week, the member in default shall forfeit his membership, and the Committee shall announce to the members that he has retired from the Exchange, and his name shall be erased from the list of members.

(e) A member, or his partner or clerk being a member, shall not vote at any meeting at which a charge affecting such member is under consideration.

(f) The Committee for the time being may, in their absolute discretion, and in such manner as they think fit, notify, or cause to be notified, to the public that any member has been expelled, or has become a defaulter, or has been suspended, or has ceased to be a member.

No action or other proceeding shall, under any circumstances, be maintainable by the person referred to in such notification against any member or official publishing or circulating the same, and this rule shall operate as leave and authority to any member or official to publish or circulate such notification, and be pleadable accordingly.

(g) A member under suspension shall not attend any meeting of the Exchange unless by leave of the Chairman, and then only for the purpose of speaking on a motion that he be fined or expelled, and having spoken he must withdraw. Such member shall not be entitled to vote.

Alteration of Rules.

26. (a) These rules shall not be amended, repealed, or added to except by a vote of two-thirds of the members present at a special general meeting called for the purpose.

(b) Notice shall be given in writing, addressed to the Secretary, of any proposed amendment, or repeal of, or addition to the rules. A special general meeting may be called to consider any proposed alteration, and at least seven days' notice of such meeting shall be given to the members by circular, sent to the last known business address of each member. The circular shall contain a copy of the proposed alteration, but the accidental omission to give any such notice to any member shall not invalidate any proceedings taken, or any resolution passed at such meeting.

Regulations under the Government Railways Acts.

IN pursuance and exercise of the powers conferred upon it by the Government Railways Act, 1926, and its amendments, the Government Railways Board hereby resolves to amend the regulations made under the Government Railways Act, 1908, on the 12th day of June, 1922, and published in the *Gazette* of the 15th day of June, 1922 (as from time to time amended, and as the same are enuring under the Government Railways Act, 1926), in the manner set forth in the Schedule hereto; and it is hereby further resolved that, except as may be otherwise provided in the said Schedule, such amendments shall come into operation on the 6th day of December, 1931.

SCHEDULE.

REGULATION 35.

PARAGRAPH (a): By inserting, immediately following the words "five years" in the first line, the words "except in the plumbing trade, in which the period shall be six years."

By adding thereto the following paragraph, viz. :—

"(c) Notwithstanding the provisions of paragraph (b) hereof, any time lost prior to 12th September, 1929, shall be made up at the expiration of the last year of apprenticeship duly completed in accordance with the said paragraph (b), the apprentice being deemed to be a Junior tradesman while making up the same."

REGULATION 73.

By omitting this regulation and substituting the following in lieu thereof :—

"73. (1) If and whenever an employee in Division II is on duty for a continuous period of not less than eleven hours, and (being at his home station) is not allowed time off duty at such station for the purpose of taking a meal during such period, and he actually purchases a meal during such period of duty, he will be paid an allowance of 2s.

"(2) The General Manager may require any claimant for payment of this allowance to produce such evidence as is satisfactory to the General Manager that the claimant is entitled to such payment."

REGULATIONS 97, 98, AND 100.

By omitting these regulations and substituting the following in lieu thereof :—

“ 97. Where reasonably practicable, the hours of duty (exclusive of meal hours) of employees in Division I and casual employees in the Clerical Branch shall be not more than forty-eight per week.”

“ 98. (a) If any question shall arise as to whether it is or is not reasonably practicable for the weekly hours of duty of any employee in Division I or any casual employee in the Clerical Branch to be regulated in accordance with Regulation 97, such question may be referred to the General Manager, whose decision thereon shall be final in each case.

“ (b) In any case where it is not reasonably practicable to regulate the hours of duty of any employee in Division I or any casual employee in the Clerical Branch in accordance with Regulation 97, the General Manager may grant to such employee such leave of absence to compensate therefor as he may deem equitable in each case.”

“ 100. Time worked by employees in Division I and casual employees in the Clerical Branch on any Sunday, and paid for at the appropriate rate under Regulation 101, shall not be taken into account for the purposes of Regulations 97 and 98.”

REGULATION 101.

Paragraph (3): By omitting the words “ and time worked by them on Christmas Day, Anzac Day, Good Friday, Sovereign's Birthday, and Labour Day.”

Paragraph (4): By omitting the words “ Christmas Day, Anzac Day, Good Friday, Sovereign's Birthday, or Labour Day.”

(The foregoing amendments to Regulation 101 shall be deemed to have come into operation on the 17th day of October, 1931.)

REGULATION 105.

Paragraph (1), subparagraph (e); By inserting immediately before the word “ Signal ” in the third line thereof the word “ Stores.”

Paragraph (2): By omitting the words “ Christmas Day, Good Friday, Labour Day, Sovereign's Birthday, Anzac Day.”

(The foregoing amendment to paragraph (2) of Regulation 105 shall be deemed to have come into operation on the 17th day of October, 1931.)

REGULATION 107.

By omitting this regulation and substituting the following in lieu thereof :—

“ 107. (1) Depot-chargemen, night foremen of cleaners, guards, porters (except tablet-porters), shunters, signalmen, storemen, train-examiners, crane-drivers in the Traffic and Locomotive Branches, gasmen, and coalmen will be paid at one-and-a-quarter times the member's ordinary rate of pay in each case for all ordinary time worked between the hours of 10 p.m. and 6 a.m.

“ (2) For all ordinary time worked by an engine-driver or a fireman between the hours of 10 p.m. and 6 a.m. payment shall be made in accordance with the following subparagraphs of this paragraph, viz :—

“ (a) While employed in driving or firing (such terms for the purpose of this regulation being deemed to include the preparing and putting away of an engine): At one-and-a-quarter times the member's ordinary rate of pay in each case.

“ (b) While employed on work other than that of driving or firing: At the member's ordinary rate of pay, in each case, or at the minimum rate of pay payable to employees who ordinarily perform such other class of work for work performed between the said hours, whichever shall be the greater.”

REGULATION 114.

Paragraph (1): By omitting the words “ Christmas Day, Good Friday, Anzac Day, Sovereign's Birthday, or Labour Day,” and the words “ in each case.”

Paragraph (2): By omitting this paragraph and substituting the following :—

“ (2) Time worked on any Sunday will in all cases stand by itself, and shall not be taken into account in computing overtime. Any amount paid in respect of time worked on any Sunday shall not be taken into account for the purposes of Regulation 104.”

(The foregoing amendments to Regulation 114 shall be deemed to have come into operation on the 17th day of October, 1931.)

REGULATION 143.

Paragraph (1), subparagraph (i): By omitting the words “ last two ” and substituting therefor the words “ fourth and fifth.”
