I N pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Dunedin City Council on the ninth day of December, one thousand nine hundred and thirty-one,

"That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the undermentioned portions of streets in the said City of Dunedin, viz:—

- (a) Portion of the south-western side of English Avenue where it abuts on Lot 3, Block I, Township of Barrfield; and
- (b) Portion of the north-western side of Stansfield Street where it abuts on Lots 3 and 4, Block I, Township of Barrfield; as the said portions of streets are more particularly shown

on the plan annexed hereto and are thereon coloured brown and edged with red to their respective centre-lines";

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the southsmall at any time be erected on the land fronting the south-western side of the portion of English Avenue or the north-western side of the portion of Stansfield Street (described in the Schedule hereto), within a distance of thirty-three feet from the centre-lines of the said portions of streets.
