Declaring Land in the North Auckland Land District to be subject to the Land for Settlements Act, 1925.

BLEDISLOE, Governor-General.

In pursuance and exercise of the powers conferred by section one hundred and five of the Land for Settle-ments Act, 1925, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby declare that the area of Crown land described in the Schedule hereto shall be subject to the provisions of the Land for Settle-ments Act, 1925, and shall hereafter form part of the Puni Settlement.

WHEREAS by the three-hundred-and-fifty-ninth section of the Land Act 1924 the W neuronal by the three-hundred-and-fifty-ninth section of the Land Act, 1924, it is enacted that the Governor-General may from time to time set apart temporarily as reserves, notwithstanding that the same may be then held under pastoral license, any Crown lands which in his opinion are required for any of the purposes in the said section mentioned :

And whereas the land described in the Schedule hereto was by Warrant dated the eighth day of January, one thousand nine hundred and thirty-two, and published in the *Gazette* of the fourteenth day of that month, temporarily reserved under the authority of the said Act for a site for a ladies' rest-room and a dental clinic:

Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon me by the said Act, do hereby permanently reserve the land described in the Schedule hereto for a site for a ladies' rest-room and a dental clinic, for which the said land was so temporarily reserved as aforesaid.
