Classification of Roads in Castlepoint County.

IN pursuance and exercise of the powers conferred on me by the Transport Department Act, 1929, and the Heavy Motor-vehicle Regulations, 1932, I, Ethelbert Alfred Ransom, Acting Minister of Transport, do hereby declare that the roads described in the Schedule hereto, and situated in the Castlepoint County, shall belong to the respective classes of roads shown in the said Schedule.

SCHEDULE.**CASTLEPOINT COUNTY.**

ROADS classified in Class Three: Available for the use thereon of any heavy motor-vehicle (other than a multi-axled heavy motor-vehicle) which with the load it is carrying weighs not more than 6½ tons, or any multi-axled heavy motor-vehicle which with the load it is carrying weighs not more than 10 tons.

Main Highway No. 64: Masterton-Weber Junction, Castlepoint, via Tinui (all that portion within Castlepoint County).

Tinui-Alfredton Road (all that portion within Castlepoint County).
