And whereas a resolution was passed by the Hobson County Council on the twentieth day of October, one thousand nine hundred and thirty-one, praying for the alterations of the boundaries of the Hobson and Whangarei Counties in the manner described in the said resolution and in the First Schedule hereto:

And whereas a similar resolution was passed by the Whangarei County Council on the thirteenth day of November, one

thousand nine hundred and thirty-one:

And whereas it is expedient to make such alterations in

And whereas it is expedient to make such alterations in accordance with the said resolutions, and that the areas to be added to the Whangarei County should be included in the Mangakahia Riding of that county:

Now, therefore, in pursuance and exercise of the power and authority conferred on me by the said Act, I, Charles, Baron Bledisloe, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the areas described in the First Schedule hereto, being now part of the Harbery County, shall be added to and form part of the the Hobson County, shall be added to and form part of the Whangarei County; that the boundaries of the Hobson and Whangarei Counties as so altered shall be those set forth and Whangarei Counties as so altered shall be those set forth under the respective headings in the Second Schedule hereto; that the areas added as aforesaid to the Whangarei County shall be included in the Mangakahia Riding of the said county; and that the boundaries of that riding shall be those set forth in the Third Schedule hereto:

And I do also proclaim and declare that this Proclamation shall take effect on the first day of April, one thousand nine hundred and thirty-two.
