WHEREAS notice was published in the Gazette of 1931, page 3507, of the Native Minister's intention to apply the provisions of subsection (3) of section 23 of the Native Land Amendment and Native Land Claims Adjustment Act, 1929, to Omaio 2 and other Blocks, and known as the Te Kaha Development Scheme:
