WHEREAS by subsection eight of section thirty-eight of the Native Land Act, 1931, it is enacted that in all cases where an order is dated more than five years previously to the receipt of the application, the Chief Judge of the Native Land Court shall first obtain the consent of the Governor-General in Council before making any order thereunder: And whereas application has been made to the Chief Judge under the said section to amend the respective succession orders made by the Native Land Court and described in the Schedule hereto:
