the Second Schedule hereto, shall, subject to all existing regis-tered mining privileges, be exempted from the provisions of the Mining Act, 1926, and its amendments, set out in the First Schedule hereto :

Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon me by exercise of the powers and autorities conferred upon me by section twenty of the Mining Act, 1926, and of all other powers and authorities in anywise enabling me in that behalf, do hereby exempt the land particularly described in the Second Schedule hereto from the provisions of those sections of the Mining Act, 1926, mentioned in the First Schedule hereto, subject to all existing registered mining privileges; and do also hereby declare that such exemption shall take effect from the date of the publication of this notice in the *Gazette*.
