KAWHIA COUNTY COUNCIL.

RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Kawhia County Council hereby resolves as follows :

"That, for the purpose of providing the interest and repay-ment of principal and other charges on a loan of £600, authorized to be raised by the Kawhia County Council under the above-mentioned Act for the purpose of metalling roads in the Te Maika Special Rating Area, the said Kawhia County Council hereby makes and levies a special rate of 2§d. in the pound upon the rateable value of all rateable property in the Te Maika Special Rating Area, comprising all that area described in the Schedule hereto, on the basis of the un-improved value, and that such special rate shall be an annual recurring rate during the currency of such loan, and shall be recurring rate during the currency of such loan, and shall be payable yearly on the 1st day of April in each and every year during the currency of such loan, being for a period of twenty years, or until the loan is fully paid off.

SCHEDULE.

Te Maika Road Special Rating Area.
