*Allocating Land reserved and taken for a Railway to the Purposes of a Road in the County of Piako, at Walton.*

A PROCLAMATION.

WHEREAS the land described in the Schedule hereto forms part of land taken for the purposes of the Thames Valley - Rotorua Railway, and it is considered desirable to allocate such land to the purposes of a road: Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by section two hundred and twenty-six of the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto shall, upon the publication hereof in the *New Zealand Gazette*, become a road, and that the said road shall be under the control of the Piako County Council, and shall be maintained by the said Council in like manner as other public highways are controlled and maintained by the said Council.

SCHEDULE.

APPROXIMATE areas of the pieces of land: 1 acre 0 roods 10-52 perches and 1 acre 0 roods 6-38 perches. Portions of Railway Reserve (parts Lot 3, D.P. 64, being part Te Pae-o-tu-Rawaru No. 2 Block) Block VIII, Wairere Survey District, Piako County. (S.O. 27034, blue.)

In the Auckland Land District; as the same are more particularly delineated on the plan marked L.O. 2643, deposited in the office of the Government Railways Board at Wellington, and thereon coloured yellow.

A PROCLAMATION.

WHEREAS it has been found desirable for the use, convenience, and enjoyment of the Thames Valley - Rotorua Railway to take further land at Walton, in addition to land previously acquired for the purposes of the said railway:

Now, therefore, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, in exercise of the powers and authorities conferred on me by sections thirty-four and two hundred and sixteen of the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes above mentioned.

SCHEDULE.

APPROXIMATE area of the piece of land: 1 acre 0 roods 13-36 perches. Portion of road (Te Pae-o-tu-Rawaru No. 2 Block), Block VIII, Wairere Survey District, Piako County. (S.O. 27034, blue.)

In the Auckland Land District; as the same is more particularly delineated on the plan marked L.O. 2643, deposited in the office of the Government Railways Board at Wellington, and thereon coloured green.
