The Makarini Scholarships tenable at Te Aute College, Hawke's Bay.

TWO scholarships of the yearly value of £35, tenable for two years, are offered for competition in the year 1933 among Maori boys on the conditions set forth in the Regulations of the Trustees of the Te Makarini Scholarships Fund. One of these scholarships, called the Senior Makarini Scholarship, is open to all Maori boys under sixteen years of age on the 1st December, 1933. The other scholarship, called the Junior Makarini Scholarship, is open to Maori boys who have been in regular attendance at Native Schools and are under fourteen years of age on the 1st December, 1933. Candidates will be required to present themselves for examination at the nearest centre where the appropriate examination is being held.

Candidates must, either directly or through their teachers, send notice to the Director of Education, Education Department, Wellington C. 1, of their intention to present themselves for examination. Such notice must be posted so as to reach the Department not later than the 30th September, 1933.

Copies of the regulations and forms of notice may be obtained from the Director of Education, Wellington C. 1.

The Industrial Conciliation and Arbitration Amendment Act, 1932.—Notice of Cancellation of Award.

In the matter of the Industrial Conciliation and Arbitration Act, 1925, and its amendments, and in the matter of an industrial dispute between the New Zealand Federated Master Painters, Decorators, and Signwriters' Industrial Association of Employers, applicant, and the New Zealand Federated Painters and Decorators' Industrial Association of Workers, respondent.

WHEREAS the Conciliation Commissioner, by notice under his hand dated the 21st day of August, 1933, has notified the Clerk of Awards that a settlement of the above-mentioned dispute has not been arrived at by the Council of Conciliation appointed for the hearing thereof, notice is hereby given that in accordance with section 7 (4) of the Industrial Conciliation and Arbitration Amendment Act, 1932, the Northern, Taranaki, Wellington, Nelson, Canterbury, and Otago and Southland Painters and Decorators' award, dated the 15th December, 1928, and published in Book of Awards, Vol. XXVIII, page 950, is deemed to be cancelled and ceases to be in force on the expiration of one month from the date of the Commissioner's notification to the Clerk of Awards as aforesaid.
