

of such determination to him pay into the Public Account at the Bank of New Zealand to the credit of the Consolidated Fund the sum of £5 as a fee for the rehearing.

(3) If the applicant does not proceed with the rehearing at the time and place fixed by the Appeal Board, either originally or at a later date, then the said sum shall be forfeit to the Crown, and the Board may make such order as it thinks fit in respect of its original determination, either confirming the same or varying it in such respect as it thinks fit whether or not the said applicant or any of the parties appears.

(4) In the event of an application for rehearing being granted before the original determination of the Board has been given effect to by the appropriate licensing authority, then the provisions of subsections (4) and (5) of section 43 of the said Act shall apply as if the reference in those subsections to an appeal were a reference to the granting of a rehearing of an appeal.

13. In all respects, other than as hereinbefore provided, the provisions of the said Act and any regulations issued thereunder shall, so far as they are applicable, apply to the rehearing of an appeal as if it were an original appeal.

Amending Regulations relating to Passenger-services under the Transport Licensing Act, 1931.

ORDER IN COUNCIL.

At the Government House at Wellington, this 4th day of September, 1933.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers conferred on him by the Transport Licensing Act, 1931, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations by way of amendment to the Transport Licensing (Passenger-services) Regulations, 1933 (hereinafter referred to as "the said regulations"), published in the *Gazette* of the thirteenth day of April, one thousand nine hundred and thirty-three, at page 737.

REGULATIONS.

1. THESE regulations may be cited as the Transport Licensing (Passenger-services) Regulations, Amendment No. 1.
2. Regulation 3 of the said regulations is hereby amended—
 - (a) By inserting the words "or permit" after the word "fitness" wherever it occurs and after the word "certificate" where last occurring in clause (1) thereof;
 - (b) By adding thereto the following clause:—
 - (3) Application shall not be made for a permit for a period exceeding three months."

3. Subclause (i), clause (2), of Regulation 10 of the said regulations is hereby amended by omitting the words "upon being officially notified of this fact," and by adding thereto the following words: "and if he omits so to do shall furnish all such assistance as may be necessary to enable the certificate or permit to be removed from the vehicle by an authorized person."

4. Regulation 21 of the said regulations is hereby amended—

- (1) By revoking subparagraph (ii) of paragraph (a) of clause (1), and substituting therefor the following:—
 - "(ii) Accompanying every application £ s. d.
for a temporary passenger-service license . . . 0 2 6"

(2) By adding to clause (1) the following paragraphs:—

- "(i) Accompanying every application for a permit if the period for which the permit is applied for—
 - "(a) Does not exceed seven days . . . 0 2 6
 - "(b) Exceeds seven days but does not exceed one month . . . 0 5 0
 - "(c) Exceeds one month but does not exceed two months . . . 0 10 0
 - "(d) Exceeds two months but does not exceed three months . . . 0 15 0"

(3) By revoking paragraph (c) of clause (1) and substituting therefor the following:—

- "(c) Accompanying every application for a certificate of fitness for a passenger-service vehicle, if the period for which the certificate of fitness is applied for—
 - "(i) Does not exceed three months . . . 0 15 0
 - "(ii) Exceeds three months but does not exceed six months . . . 1 10 0
 - "(iii) Exceeds six months but does not exceed nine months . . . 2 5 0
 - "(iv) Exceeds nine months but does not exceed twelve months . . . 3 0 0
 - "(v) Exceeds twelve months . . . 3 0 0
 With an additional 0 15 0 for each additional period of three months or part thereof.
- "(cc) For every variation in the terms of a certificate of fitness . . . 0 10 0"

(4) By revoking in paragraph (h) of clause (1) the words "For every permission granted," and substituting the words "Accompanying every application."

5. Regulation 14 of the said regulations is hereby amended by omitting the word "unavoidable," and by inserting after the word "notified" the words "by the licensee."

6. The Schedule to the said regulations is hereby amended by substituting for Form B therein the Form B as hereinafter described.
