Order in Council authorizing the Waimea Electric-power Board to borrow Moneys (£1,000) by way of overdraft.

ORDER IN COUNCIL.

At the Government House at Wellington, this 18th day of September, 1933.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS the Waimea Electric-power Board (hereinafter called "the said local authority"), being desirous of borrowing moneys by way of overdraft under section seventy of the Electric-power Boards Act, 1925, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council, as required by the said Act, should be given to the borrowing as aforesaid :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the borrowing of moneys by the said local authority under the said section seventy, and in giving such consent doth hereby determine as follows :—

1. Such borrowing may be from time to time by way of bank overdraft.

2. The rate of interest payable from time to time shall not exceed current bank-overdraft rates of interest to best customers.

3. No money shall be borrowed under this consent at any time after the thirty-first day of March, one thousand nine hundred and thirty-four.

4. The total amount owing (including unpaid interest, if any) on the moneys so borrowed shall not on the thirty-first day of March, one thousand nine hundred and thirty-four, exceed the sum of one thousand pounds (£1,000).

5. The amount so borrowed shall be liquidated in the financial year 1934-35 either from revenue or from the proceeds of a rate to be struck if necessary to ensure the fulfilment of this condition.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by Order in Council made on the seventh day of August, one thousand nine hundred and thirty-three, and subject to the determinations as to borrowing and repayment therein set out, consent was given to the raising by the Invercargill City Council (hereinafter called "the said local authority") of the sum of twenty-three thousand one hundred pounds (£23,100) by a loan to be known as "Electricity Redemption Loan (No. 5), 1933" (hereinafter called "the said loan") :

And whereas one of the determinations aforesaid is that the rate of interest that may be paid in respect of the said loan shall not exceed four pounds two shillings and sixpence (£4 2s. 6d.) per centum per annum :

And whereas the said loan has not yet been raised and it is expedient to vary such determination :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the Local Government Loans Board Act, 1926, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby vary the determination aforesaid by prescribing that the rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding four pounds five shillings (£4 5s.) per centum per annum.

Order in Council consenting to the Raising of a Loan of £1,200 by the Hikurangi Town Board and prescribing the Terms thereof.

ORDER IN COUNCIL.

At the Government House at Wellington, this 18th day of September, 1933.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS the Hikurangi Town Board (hereinafter called "the said local authority") proposes, pursuant to the terms of a requisition issued under section twenty-two of the Health Act, 1920, to raise the sum of one thousand two hundred pounds (£1,200) by a loan to be known as "Water-main Loan, 1933," for the purpose of supplementing the existing water-supply by replacing the present 5 in. steel main with a 9 in. concrete main :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the Local Government Loans Board Act, 1926, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising by the said local authority of the said loan up to the amount of one thousand two hundred pounds (£1,200), and in giving such consent doth hereby determine as follows :—

1. The term for which the said loan or any part thereof may be raised shall not exceed three (3) years.

2. The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding four pounds five shillings (£4 5s.) per centum per annum.

3. The said loan shall be repaid by annual instalments of principal of not less than four hundred pounds (£400) during the first two years of the currency of the loan, and the balance in the third year.

4. The rate of brokerage that may be paid in respect of the raising of the said loan or any part thereof shall not exceed one-half per centum on any amount raised.

5. The payment of interest and repayment of principal in respect of the said loan shall be made in New Zealand.
